ORDER

I.

Request to Amend Common Carrier Authority

By Decision and Order No. 23534, filed on July 2, 2007, MKC TRUCKING LLC ("Applicant") was granted a certificate of public convenience and necessity to operate as a common carrier of property by motor vehicle over irregular routes on the island of Oahu in the general commodities and dump truck classifications.

On October 1, 2007, Applicant filed a letter requesting that its authority in the general commodities classification be surrendered, as it does not plan to utilize this classification for any of its hauling work. Accordingly, we find good cause to grant Applicant's request and amend Decision and Order No. 23534 to reflect such surrender of authority.

II.

Orders

THE COMMISSION ORDERS:

1. Applicant's request to surrender its authority in the general commodities classification is granted.

2. Decision and Order No. 23534 is amended consistent with the terms of this Order. Specifically, ordering paragraph 1 in Decision and Order No. 23534 is amended as follows:

"Applicant is granted a Certificate to operate as a common carrier of property by motor vehicle over irregular routes on the island of Oahu in the dump truck classification."

In all other respects, Decision and Order No. 23534 remains unchanged.
