ORDER CLOSING DOCKET

By this Order, the commission closes this docket.

I.

Docket No. 2007-0149

By Order No. 23483, filed on June 8, 2007, in Docket No. 2007-0149, the commission placed certificate of public convenience and necessity number 584-C ("Certificate No. 584-C"), held by TOMIO KUNIKANE, dba MAC TRAVEL SERVICES ("Petitioner"), on inactive status for a period of one year, until June 7, 2008.

II.

Docket No. 2007-0257

By Order No. 23758, filed on October 24, 2007, in Docket No. 2007-0257, the commission ordered Petitioner to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 20, 2007, to show cause why Petitioner's Certificate No. 584-C should not be suspended or revoked for failure to pay the civil penalty of \$1,000.00 associated with

Citation No. 0350. As Petitioner failed to appear before the commission's hearing officer on November 20, 2007, the commission, by Order No. 23906, filed on December 19, 2007, suspended Certificate No. 584-C for a period of three (3) months, effective from December 19, 2007. Ordering paragraph 2 of Order No. 23906 stated that if Respondent failed to pay the civil penalty of \$1,000.00 associated with Citation No. 0350 by the time the suspension period had expired Certificate No. 584-C would be revoked. The suspension period of three (3) months expired and Petitioner did not pay the civil penalty of \$1,000.00 associated with Citation No. 0350. The commission, thus, revoked Certificate No. 584-C by Decision and Order No. 24223, filed on May 13, 2008.

### III.

#### Findings and Conclusions

The revocation of Respondent's operating authority by Decision and Order No. 24223 in Docket No. 2007-0257 renders moot the proceedings in Docket No. 2007-0149. We, thus, conclude that there is good cause to close Docket No. 2007-0149 as moot.




