ORDER

I.

Order Amending Decision and Order No. 24103

By Decision and Order No. 24103, filed on March 25, 2008, PERFECTO ESQUEJO ACOSTA, dba D' PERFECT ADVENTURE SHUTTLE ("Applicant"), was granted a certificate of public convenience and necessity to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 1-to-7 and 8-to-25 passenger classifications.

On July 18, 2008, Applicant filed a letter requesting that his authority in the 8-to-25 passenger classification be surrendered, as he does not plan to use that classification at this time. Accordingly, we find good cause to grant Applicant's request and amend Decision and Order No. 24103 to reflect such surrender of authority.

II.

Orders

THE COMMISSION ORDERS:

1. Applicant's request to surrender his authority in the 8-to-25 passenger classification is granted.

2. Decision and Order No. 24103 is amended consistent with the terms of this Order. Specifically, ordering paragraph 1 in Decision and Order No. 24103 is amended as follows:

"Applicant is granted a Certificate to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 1-to-7 passenger classification."
