ORDER REVOKING CERTIFICATE NO. 5182-C

By this Order, the commission revokes certificate of public convenience and necessity no. 5182-C ("Certificate No. 5182-C"), held by RUBEN KAY, dba KAY TRUCKING ("Petitioner").

I.

Background

By Order No. 23670, filed on September 18, 2007, the commission placed Certificate No. 5182-C on inactive status for a period of one year, from September 18, 2007 to September 17, 2008. In the order, the commission informed Petitioner that if Certificate No. 5182-C was not reactivated prior to the expiration of the period of inactivity, i.e., by September 17, 2008, the commission would deem it to be abandoned and revoked, as required by Hawaii Revised Statutes ("HRS") § 271-19(b).

By letter filed on May 2, 2008, Petitioner requested that the commission reactivate Certificate No. 5182-C. By letter dated May 16, 2008, the commission requested that Petitioner

submit certain documents necessary to complete the reactivation process pursuant to HRS § 271-19(b).¹

II.

Findings and Conclusions

The commission did not receive the requested documents prior to the expiration of the period of inactivity, i.e., by September 17, 2008, thus, Certificate No. 5182-C was not reactivated within the statutorily approved period. The commission, thus, finds good cause to revoke Certificate No. 5182-C.

Order


THE COMMISSION ORDERS:

2. This docket is closed unless otherwise ordered by the commission.


