ORDER REVOKING CERTIFICATE NO. 1148-C

By this Order, the commission revokes certificate of public convenience and necessity no. 1148-C ("Certificate No. 1148-C"), held by AIRPORT EXPRESS VAN, INC. ("Petitioner").

I.

Background

By Order No. 23818, filed on November 9, 2007, the commission placed Certificate No. 1148-C on inactive status for a period of one year, from October 30, 2007 to October 29, 2008. In the order, the commission informed Petitioner that if Certificate No. 1148-C was not reactivated prior to the expiration of the period of inactivity, i.e., by October 29, 2008, the commission would deem it to be abandoned and revoked, as required by Hawaii Revised Statutes § 271-19(b).

Findings and Conclusions

Certificate No. 1148-C was not reactivated prior to the expiration of the period of inactivity, i.e., by October 29, 2008. We, thus, find that there is good cause to revoke Certificate No. 1148-C.
