### Orders

#### THE COMMISSION ORDERS:

1. Petitioner's Certificate No. 5219-C is placed on inactive status for an additional twelve (12)-month period, from April 13, 2008 to April 12, 2009.

2. Pursuant to HRS § 271-19(b), if Certificate No. 5219-C is not reactivated prior to the expiration of the period of inactivity, it shall be declared abandoned and revoked. The request to reactivate Certificate No. 5219-C, along with the filing of all documents necessary for reactivation must be completed prior to the expiration of the inactivity period, or Certificate No. 5219-C shall be revoked.


3. Petitioner shall not transfer its inactive certificate unless Petitioner can first establish good cause to the commission for the transfer, and the commission has approved the request to transfer.


