ORDER

By this Order, the commission revokes certificate of public convenience and necessity no. 5165-C ("Certificate No. 5165-C"), held by EXCAVATION TECH, LLC ("Petitioner").

Background

By Order No. 23308, filed on March 16, 2007, the commission placed Certificate No. 5165-C on inactive status for a period of one year, until March 15, 2008. In the order, the commission informed Petitioner that if Certificate No. 5165-C was not reactivated prior to the expiration of the period of inactivity, i.e., by March 15, 2008, the commission would deem it to be abandoned and revoked, as required by Hawaii Revised Statutes § 271-19(b).
