Reasons for Suspension: (1) Non-filing of the 2006 Annual Financial Report, due by March 31, 2007; (2) non-filing of the 2007 Annual Financial Report, due by March 31, 2008; and (3) non-payment of the public utility fees based on the telecommunications carriers 2006 gross revenues, due by July 31 and December 31, 2007.

Until the above-noted delinquencies are properly resolved, the above-referenced telecommunications carrier shall cease and desist from implementing the tariff changes set forth in its transmittal.¹




