Docket No. 2008-0223

By Notice of Violation, Order to Show Cause, and Notice of Hearing filed on October 15, 2008, in Docket No. 2008-0223, the commission ordered KAUAI MAKAMAE CORPORATION ("Respondent") to appear at 465 South King Street, Room B-3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 19, 2008, to show cause why Respondent's certificate of public convenience and necessity number 3575-C ("Certificate No. 3575-C") should not be suspended or revoked for failure to file an annual financial report and pay an annual motor carrier gross revenue fee for the year 2007,

pursuant to Hawaii Revised Statutes §§ 271-25, 271-36, and Hawaii Administrative Rules §§ 6-62-42(a), 6-62-24(a). Respondent did not appear at the hearing.

II.

Docket No. 2008-0127

By Order Terminating Certificate No. 3575-C filed on December 31, 2008, in Docket No. 2008-0127, the commission terminated Certificate No. 3575-C pursuant to Respondent's request filed on June 24, 2008 to voluntarily surrender its Certificate.

Findings and Conclusions

The revocation of Respondent's operating authority by Order Terminating Certificate No. 3575-C filed on December 31, 2008, in Docket No. 2008-0127, renders moot the proceedings in Docket No. 2008-0223. We, thus, conclude that there is good cause to close Docket No. 2008-0223 as moot.






