ORDER AMENDING DECISION AND ORDER FILED ON DECEMBER 3, 2008

I.

By the Decision and Order filed on December 3, 2008, AJ'S TOUR, LLC ("Applicant") was granted a certificate of public convenience and necessity to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Hawaii, excluding Waipio Valley, in the (1) 1-to-7 passenger classification, and (2) 8-to-25 passenger classification, limited to utilizing motor vehicles with a maximum manufacturer's seating capacity of 15 passengers.

On January 14, 2009, Applicant filed a letter requesting that its authority in the 1-to-7 passenger classification be surrendered due to the declining economy. Accordingly, we find good cause to grant Applicant's request and amend the Decision and Order filed on December 3, 2008 to reflect such surrender of authority.

Orders

THE COMMISSION ORDERS:

- 1. Applicant's request to surrender its authority in the 1-to-7 passenger classification is granted.
- 2. The Decision and Order filed on December 3, 2008 is amended consistent with the terms of this Order. Specifically, ordering paragraph 1 of the Decision and Order is amended as follows:

"Applicant is granted a Certificate to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Hawaii, excluding Waipio Valley, in the 8-to-25 passenger classification, limited to utilizing motor vehicles with a maximum manufacturer's seating capacity of 15 passengers."

In all other respects, the Decision and Order remains unchanged.
