By this Order, the commission revokes certificate of public convenience and necessity no. 4026-C ("Certificate No. 4026-C"), held by JACRO LOWBED SERVICES, INC. ("Petitioner").

I.

Background

By Order No. 24198, filed on May 9, 2008, the commission placed Certificate No. 4026-C on inactive status for a period of one year, from May 2, 2008 to May 1, 2009. In the order, the commission informed Petitioner that if Certificate No. 4026-C was not reactivated prior to the expiration of the period of inactivity, i.e., by May 1, 2009, the commission would deem it to be abandoned and revoked, as required by Hawaii Revised Statutes § 271-19(b).

Findings and Conclusions

Certificate No. 4026-C was not reactivated prior to the expiration of the period of inactivity, i.e., by May 1, 2009. We, thus, find that there is good cause to revoke Certificate No. 4026-C.


