ORDER REVOKING CERTIFICATE NO. 5199-C

By this Order, the commission revokes certificate of public convenience and necessity no. 5199-C ("Certificate No. 5199-C"), held by NARVAEZ RANCH & SERVICE LLC ("Petitioner").

I.

Background

By Order filed on September 4, 2008, the commission placed Certificate No. 5199-C on inactive status for a period of one year, from August 15, 2008 to August 14, 2009. In the order, the commission informed Petitioner that if Certificate No. 5199-C was not reactivated prior to the expiration of the period of inactivity, i.e., by August 14, 2009, the commission would deem it to be abandoned and revoked, as required by Hawaii Revised Statutes § 271-19(b).

Findings and Conclusions

Certificate No. 5199-C was not reactivated prior to the expiration of the period of inactivity, i.e., by August 14, 2009. We, thus, find that there is good cause to revoke Certificate No. 5199-C.
