ORDER REVOKING CERTIFICATE NO. 4081-C

By this Order, the commission revokes certificate of public convenience and necessity no. 4081-C ("Certificate No. 4081-C"), held by MOLOKAI OUTDOOR ACTIVITIES, LLC, dba MOLOKAI OUTDOORS ("Petitioner").

I.

Background

By Order filed on August 26, 2008, the commission placed Certificate No. 4081-C on inactive status for a period of one year, from August 26, 2008 to August 25, 2009. In the order, the commission informed Petitioner that if Certificate No. 4081-C was not reactivated prior to the expiration of the period of inactivity, i.e., by August 25, 2009, the commission would deem it to be abandoned and revoked, as required by Hawaii Revised Statutes § 271-19(b). The order also informed Petitioner that it may file prior, prior to the expiration of the period of inactivity, a request to extend its inactive status for up to one additional year.

II.

Findings and Conclusions

Certificate No. 4081-C was not reactivated prior to the expiration of the period of inactivity, i.e., by August 25, 2009, and Petitioner did not file a request to extend its inactive status by August 25, 2009.<sup>1</sup> We, thus, find that there is good cause to revoke Certificate No. 4081-C.

Order

THE COMMISSION ORDERS:

1. Certificate No. 4081-C is revoked.
2. This docket is closed unless otherwise ordered by the commission.
