ORDER VACATING THE DECISION AND ORDER FILED ON MAY 21, 2009

By this Order, the commission vacates the Decision and Order filed on May 21, 2009, and closes this docket.

I.

Application to Extend Common Carrier Authority

By Decision and Order filed on May 21, 2009, the commission approved the application of SCOTT TRUONG, dba FANTASY LIMOUSINE ("Applicant"), to extend his authority under certificate of public convenience and necessity number 1327-C to include the 1-to-7 passenger classification. We also: (1) ordered Applicant, as a condition to our approval of the application, to comply with all commission requirements for common carriers, including submitting certain documents within one hundred and twenty (120) days of the issuance of the Decision and Order; and (2) notified Applicant that failure to timely comply with the commission's requirements would constitute cause for the commission to vacate the Decision and Order. We served Applicant with a copy of the Decision and Order by mail, postage

prepaid, on the same day that the Decision and Order was issued, in accordance with Hawaii Administrative Rules §§ 6-61-21 and 6-61-122.

II.

Findings and Conclusions

The one hundred and twenty (120)-day time period has passed, and Applicant has not complied with the requirements set forth in the Decision and Order filed on May 21, 2009. The commission, thus, determines that the Decision and Order filed on May 21, 2009 should be vacated.

III.

Order

THE COMMISSION ORDERS:

The Decision and Order filed on May 21, 2009, is vacated and this docket is closed unless otherwise ordered by the commission.


