STIPULATION FOR DISMISSAL WITH PREJUDICE AS TO ALL PARTIES




This Stipulation has been signed by all appearing parties, and there are no remaining parties or claims in this action. Each party is to bear its own attorneys' fees and costs.

Administrative Hearings are scheduled for 9:00 a.m. on October 23 and 24, 2001.




