follows:

PLEASE NOTE CHANGES

**IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that the Business Registration Division of the Department of Commerce and Consumer Affairs of the State of Hawaii shall and is hereby ordered to dissolve, terminate, revoke and/or cancel, all trademarks, trade names, corporate registrations and certificates of authority held by or for Defendant Information University of America, Inc..

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that Defendant Information University of America, Inc., its agents, employees, successors and assigns, directly or indirectly, individually or in concert with others, or through any corporate or other device, be and is hereby permanently enjoined from:

- a. Providing any post-secondary instructional programs or courses leading to a degree;
- b. Acting as or holding itself out as a "college, academy, institute, institution, university" or anything similar thereto;
- c. Failing to comply with Hawaii Rev. Stat. Chap. 446E or § 480-2(a) in any particulars; and
- d. Owning or operating any business in the State of Hawaii or claiming to operate under the laws of the State of Hawaii until all restitution, civil penalties and costs entered herein are fully satisfied.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that pursuant to Hawaii Rev. Stat. § 480-3.1, Defendant Information University of America, Inc. be and hereby is liable to Plaintiff for civil penalties in the amount of \$1,000.00.


There are no remaining claims against any party. Any remaining claims be and are hereby dismissed without prejudice.
