Criswell' rights, claims, legal rights and legal claims against Executive Risk Indemnity Inc. and its insurance brokers Brown and Brown, including but not limited to any legal rights to declaratory relief, damages and bad faith. Plaintiff and Co-Receivers Rebecca S.P. Yee and Benjamin T. Fujimoto be and are hereby permitted to claim against and collect any applicable liability insurance covering Defendant Denise A. Criswell and are hereby vested of any extra-contractual rights or causes of action that Defendant Denise A. Criswell has or may have against Executive Risk Indemnity Inc., its' subsidiaries and agents.


