# **Delegation to Executive Officer**

With respect to applications from applicants who graduated from a foreign institute, school, or college with a formal program in the science of acupuncture (Oriental Medicine), for whom AACRAO issued an evaluation report that clearly states that the institute, school, or college was recognized by the applicable foreign government authority and that the program completed by the applicant is comparable to the three-years of study at a college or institute accredited by the ACAOM, it was moved by Mr. Hashimoto, seconded by Dr. Hashimoto and unanimously carried to delegate to the Executive Officer the authority to approve the applications for examination/licensure, provided that there are no issues that require the Board to exercise discretionary decision-making.

The Executive Officer stated that 90% of the eligible licensees renewed their licenses. Out of the 665 eligible, 615 licenses renewed successfully.

**New Business:** 

May Acupuncture Licensees Place Their Licenses on Inactive Status?

An email request was received from a Hawaii licensed acupuncturist suggesting that an inactive license status should be created.

Board members engaged in a brief discussion on whether an inactive status should be created, and if it were, would the inactive licensee be required to complete requirements on reactivation. A member suggested that the inactive licensee could be required to complete continuing education, demonstrate that they are currently licensed in another jurisdiction and that their license is in good standing. The Executive Officer stated that chapter 436B, HRS, has a provision that the Board could use as a means to implement an inactive status. However, if the Board wanted to require licensees to meet additional requirements, it appears that the Board's rules would need to be revised. Board members agreed by consensus that the matter can be discussed at a later date.
