The EO reported the following statistics for the December 2011 Renewals for Chiropractor licenses as of 12/27/11:

The online renewal statistics do not include the active/inactive status change renewals that require the submission of a hard copy. The deadline for renewals this year was 1/3/12. Licensees who do not renew their license have 2 (two) years to restore their license with proof of 20 hours of CE credits. The CE random audit will randomly select 5% of the chiropractors with active licenses and will be conducted after the renewal period.
