Scott K. Kuroiwa, D.C.

It was moved by Dr. Klein, seconded by Dr. Pleiss, and unanimously carried to deny the request for extension of the conditional approval of licensure for Scott K. Kuroiwa, and deemed the application for licensure abandoned based on the following statutory grounds contained within the Hawaii Revised Statutes ("HRS").

HRS §436B-9 states:

(b) An application shall be considered to be abandoned if an applicant fails to provide evidence of continued efforts to complete the licensing process for two consecutive years; provided that the failure to provide evidence of continued efforts includes but is not limited to: (1) Failure to submit the required documents and other information requested by the licensing authority within two consecutive years from the last date the documents or other information were requested;

New Business: a. Federation of Chiropractic Licensing Boards ("FCLB")

Dr. Opie stated he attended the FCLB's 85th Annual Educational Congress in May and the educational sessions covered jurisdictional mobility barriers, scope of practice, chiropractors as primary care providers, a draft Model Practice Act presented by an FCLB task force, accrediting standards, and a demonstration of the new National Board of Chiropractic Examiners ("NBCE") Ethics and Boundaries Essay Format

Dr. Opie stated some universities are advocating chiropractors to become primary care physicians and establish a new degree as Doctor of Chiropractic Medicine ("DCM"). Currently, none of the 50 states recognizes licensure as DCM.

Dr. Opie stated the FCLB delegate body voted to admit the Australian and New Zealand boards as its newest members.

Dr. Morelli stated the Councils on Chiropractic Education International ("CCEI") is a recognized organization .
