It was moved by Ms. Nakagawa, seconded by Ms. Nonaka, and unanimously carried to inform Ms. Dellman that the Board previously made the determination that under the current rules, dental hygienists are allowed to use laser for curettage and has not changed its determination. Therefore lasers can be used for treating periodontal pockets.

Ms. Nadai inquired whether dental hygienists were allowed to use lasers on soft tissue.

It was moved by Ms. Nakagawa, seconded by Ms. Nonaka, and unanimously carried to inform Ms. Nadai that the Board previously made the determination that under the current rules, dental hygienists are allowed to use laser for curettage and has not changed its determination. Therefore lasers can be used on soft tissue.

# 6. Old Business a. Discussion on 2012 Legislation

Ms. Nonaka reported that a hearing on H.B. 1876, HD1 (Relating to Dental Hygienists) was held and that the Senate version was going to be heard the following day. The intent of these bills is to educate the public for their safety that the dental hygienist in the office is properly licensed. It also serves as notice to the dentist that their dental hygienist's license is current. The level of anesthesia allowed to perform is also shown on the card.

Mr. Kobashigawa informed the Board that the following names were submitted by the Governor's Office:

#### b. Correspondence from Dr. Craig Fujioka

Dr. Sherman reported that the Investigative Committee ("IC") met and concluded that the use of BOTOX falls within the scope of practice of dentistry as defined by Hawaii statues. The IC recommends that licensed dentists in Hawaii, including general dentists, oral maxillofacial surgeons and other ADA/CODA recognized dental specialists be allowed to use BOTOX specifically for the treatment of TMD/myofacial pain or other conditions specific to within the oral cavity complex. Dental practitioners should receive appropriate training, acquire necessary knowledge, skills and experience necessary to provide this service in a safe and efficacious manner.

The IC also concluded that the use and placement of dermal fillers by general dentists, oral surgeons and other ADA/CODA recognized dental specialists licensed in Hawaii is within the scope and practice of dentistry. Dermal fillers may be utilized by general practice dentists provided these treatments are specifically reserved only for intra-oral conditions/procedures.

The use of BOTOX and placement of dermal fillers must be completed only by the licensed dentist possessing the appropriate training, knowledge, and skill set. It cannot be delegated to a dental hygienist or dental assistant.

Pursuant to the "Sunshine Law" requirements, the Board cannot make a determination at this meeting and will have further discussions and make a determination at its next meeting scheduled for May 21, 2012.

opportunity to take classes at the Hawaii Dental Association's Convention. He's requesting for either a modification to the number of required CE or the amount of CE credits allowed to take online due to his disability.

c. Practice Management Article on Mid-Level Providers

A legislative bill was introduced in California to study the benefits of alternative dental care providers. The California Dental Association ("CDA") supports the proposed legislation, but two other state dental groups, the California Academy of General Dentistry and the California Association of Oral and Maxillofacial Surgeons oppose the concept of midlevel providers saying they lack the necessary training to do irreversible procedures. This bill would also establish a state dental director who could help California secure federal funds for subsidized dental programs.

# f. <u>Professional Licensing Report</u>

From the November/December 2011 issue:

"FTC Sanctions board for anti-competitive practices"

The Federal Trade Commission ("FTC") issued an opinion and final order in its case against the North Carolina board of Dental Examiners. The ruling prohibits the board from issuing cease and desist letters to providers of teeth-whitening services or from claiming any authority to declare unlicensed teeth-whitening services in violation of the law. Although the state's dental act prohibits unlicensed individuals from removing stains from teeth, it does not give the dental board the power to enforce that prohibition on its own.

"Medical board must accept ALJ's findings of fact & conclusions of law"

The Texas Board of Medical Examiners may no longer go its own way on contested cases. In addition to eliminating anonymous complaints, the state medical board must dispose of contested cases by issuing a final order based on the findings of fact and conclusions of law of an administrative law judge ("ALJ") at the State Office of Administrative Hearings.
