6. <u>New Business</u>: a. <u>Department of Health – Sanitation certificates for massage</u> establishments

EO Nichols reported that the Board recently received a letter from the Department of Health's Sanitation Branch stating that effective April 1, 2013, they will no longer be conducting sanitation inspections of massage establishments and therefore, will no longer be issuing the sanitation clearances.

After some discussion, it was the consensus of the Board to direct DAG Tam and EO Nichols to amend the massage establishment application. Substantive changes include:

- amending the attestation to include §11-11-4, Hawaii Administrative Rules ("HAR");
- removal of the sanitation clearance requirement;
- requiring all applicants provide the following information:
 - a. A letter signed by the Principal Massage Therapist AND officer, director, partner or member, of the entity, as applicable, that describes the massage therapy activity that will be performed. Include the days and times of operation.
 - b. A copy of the written agreement with the owner, manager or rental agent of the venue citing to their knowledge and authorization for the massage therapy activity. Be sure that the name of the massage therapy establishment is cited in the agreement.
 - c. A drawing or sketch of the venue showing the surrounding area and the stall/booth that the applicant will occupy. The sketch shall show where the restrooms are located. Sketch shall be on nonlined letter sized paper of 8 1/2" x 11".

By consensus, the Board deferred discussion on the rule revisions to HAR Chapter 84.
