The Board reviewed and considered all of the records and files of Dr. Brooks' application and information received from him as well as other organizations.

After due consideration of this information, it was moved by Chair Takanishi, seconded by Dr. Chin, and unanimously carried to defer Dr. Brook's application pending additional information and further review.

Michele J. Lea-Stokes, M.D.

The Board reviewed and considered all of the records and files of Dr. Lea-Stokes' application and the information received from her as well as from other organizations. These records and files reflect:

1) the disciplinary action taken against Dr. Lea-Stokes' Texas medical license, including a Mediated Order dated April 6, 2005, requiring, among other things, that Dr. Lea-Stokes' medical records shall be monitored for a period of one year by a physician; and 2) the disciplinary action taken against Dr. Lea-Stokes' Pennsylvania medical license, which required that she pay a civil penalty in the amount of \$1,000.

After due consideration of this information, it was moved by Dr. Kosasa, seconded by Dr. Sept, and unanimously carried to deny Dr. Lea-Stokes' application for licensure, basing its decision on the following grounds of the Hawaii Revised Statutes ("HRS"), which find support in the records and files of Dr. Lea-Stokes' application:

HRS § 453-8(a)(7): Professional misconduct, hazardous negligence causing bodily injury to another, or manifest incapacity in the practice of medicine, osteopathy, or surgery;

HRS § 453-8(a)(9): Conduct or practice contrary to the

recognized standards of ethics of the medical profession as adopted by the Hawaii Medical

Association, the American Medical Association, the Hawaii Association of

Osteopathic Physicians and Surgeons, or the American Osteopathic Association; and

HRS § 453-8(a)(11): Revocation, suspension, or other disciplinary

action by another state or federal agency of a

license, certificate or medical privilege for

reasons as provided in this section.

Based upon the foregoing, the Board believes Dr. Lea-Stokes actions reflect conduct or practice contrary to the recognized standards of the medical profession.

John P. Santiago, M.D.

This committee hopes to advise the DOH's Emergency Medical Services and Systems Advisory Committee in October 2011 of its position regarding national standards relating to curriculum, levels of certification, scope of practice and certification.

Chair Takanishi recommended that the Director of DCCA be briefed. He also went on to say that in developing rules, the Board will balance public safety with access to practice to insure the licensing requirements respect public safety but not be so prohibitive as to deny access to licensure.
