Mary K. Nordling, M.D.

After due consideration of the information received, it was moved by Dr. Chin, seconded by Dr. Kosasa and unanimously carried to defer Dr. Nordling's application for medical licensure pending receipt of additional information.

Arash Salemi, M.D.

It was moved by Dr. Barrickman, seconded by Dr. Kosasa and carried by a majority, with Dr. Akaka abstaining, to approve Dr. Salemi's application for licensure.

Unfinished Business: a. Rules Revisions: PA Provisions

Executive Officer Cabral advised the Board that the Ad Hoc Committee on the PA Rules Revisions did not have an opportunity to meet. As such, the Ad Hoc Committee will be presenting recommendations to the Board at its next Board meeting.

New Business: a. Legislation:

S.B. No. 548, relating to telemedicine

The Board supports this bill with the exception of the inclusion of "behavioral health professionals". The Board expressed its concern with the term as it is not defined. The addition of behavioral health professionals to HRS section 453-2 means that HRS Chapter 453 does not apply to professionals such as social workers, psychologists, marriage and family therapists, etc. Furthermore, the Board is not aware that behavioral health professionals can be credentialed by a hospital.

S.B. No. 506, S.D.1, relating to professional and vocational licensing

The Board determined that it would take no position on this matter.

S.B. No. 608, relating to medicine

The Board expressed its concerns with Senate Bill No. 608, S.D.1 which adds two new sections to Hawaii's medical licensing law to provide that the medical board (1) periodically disseminate information and educational material regarding prevention and treatment of chronic disease, through the application of changes in nutrition and lifestyle behavior, to each licensed physician and surgeon and to each hospital in the state; and (2) set content Hawaii Medical Board Minutes of Meeting of February 14, 2013 Page 5

standards for continuing education requirements concerning chronic disease.

With regard to providing information and educational materials to licensed physicians and surgeons and to hospitals regarding prevention and treatment of chronic disease, the Board notes that because the Board's primary function as a licensing board is to protect consumers through implementation of the applicable licensing law and rules, its educational focus relates primarily to updating its licensees regarding changes to the existing law and rules, and providing licensees with information about specific board actions and interpretations that may impact licensee conduct.

With regard to setting content standards for continuing medical education ("CME") requirements, the Board feels that physicians should obtain CME within their specialty and prefers to give physicians the latitude to determine what those CME would be. Requiring content-specific CME may be burdensome, especially to Board-certified physicians. This is because these physicians must meet their specialty board CME requirements for recertification and CME in chronic disease might not be accepted towards recertification in specialties such as surgery, OB-GYN, etc. This being the case, physicians would need to take additional CME (in chronic disease) in order to renew their licenses.

S.B. No. 655, S.D.1, relating to health

The Board believes that it does not have the expertise to oversee the implementation of this bill.

S.B. No. 1078, relating to enforcement tools to improve patient safety

The Board expressed its opposition with section 1 of the bill which adds a new provision on summary suspension and supports section 2 which amends HRS section 453-8. It supports the proposed draft agreed to by RICO and HMA.

H.B. No. 323, relating to professional and vocational licensing

The Board determined that it would take no position on this matter.
