Adjudicatory Matters:

Chair Takanishi called for a recess from the meeting at 1:09 p.m. to discuss and deliberate on the following adjudicatory matters pursuant to HRS Chapter 91.

a. <u>In the Matter of the License to Practice Medicine of Carol a.</u> Brown, M.D.; MED 2011-6-L

After discussion, it was moved by Mr. Cody, seconded by Dr. Desai, and unanimously carried to accept the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

b. <u>In the Matter of the License to Practice Medicine of James</u> R. Frede, M.D.; MED 2012-180-L

After discussion, it was moved by Dr. Barrickman, seconded by Dr. Akaka, and unanimously carried to accept the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order.

It was moved by Dr. Barrickman, seconded by Dr. Akaka, and carried by a majority, with Dr. Desai abstaining, to approve the minutes of the February14, 2013 meeting as circulated.

The Board reviewed and considered the records and files of Dr. Nam's application and the information received from her as well as from other organizations, including but not limited to the University of California, Davis, Department of Anesthesiology and Pain Medicine ("Department"), concerning the above-referenced matter. These records and files reflect Dr. Nam's: 1) poor performance as an anesthesiology resident; 2) failure to meet the core competencies of the Accreditation Council for Graduate Medical Education; and 3) dismissal from the Department effective February 2, 2012.

After due consideration of the information received, it was moved by Dr. Desai, seconded by Dr. Barrickman and unanimously carried to deny Dr. Nam's application for licensure, basing its decision on the following legal grounds of the Hawaii Revised Statutes ("HRS"), which find factual support in the records and files of Dr. Nam's application:

HRS § 453-8(a)(7): Professional misconduct, hazardous

negligence causing bodily injury to another, or

manifest incapacity in the practice of medicine, osteopathy, or surgery;

HRS § 453-8(a)(8): Incompetence or multiple instances of

negligence, including but not limited to the consistent use of medical service, which is

inappropriate or unnecessary;

HRS § 436B-19(8): Failure to maintain a record or history of

competency, trustworthiness, fair dealing, and

financial integrity; and

HRS § 436B-19(12): Failure to comply, observe, or adhere to any

law in a manner such that the licensing authority deems the applicant or holder to be an unfit or improper person to hold a license.

Donald P. Schaefer, M.D.

The Board reviewed and considered all of the records and files of Dr. Schaefer's application and information received from him as well as from other organizations, including but not limited to: 1) Dr. Schaefer's "yes" answer to question 8 on the Board's application; 2) Dr. Schaefer's statement of explanation dated February 5, 2013, in which he disclose his history of marijuana use; and 3) letters from the Missouri Physicians Health Program ("Missouri Program") dated January 30, 2013 and March 8, 2013, regarding Dr. Schaefer's agreement for participation in the Missouri Program.

After due consideration of the information received, it was moved by Dr. Barrickman, seconded by Dr. Kosasa and unanimously carried to approve Dr. Schaefer's application for licensure subject to conditions, basing its decision on the following grounds of the Hawaii Revised Statutes:

HRS § 453-8(a)(4): Being habituated to the excessive use of drugs

or alcohol; or being addicted to dependent

on, or a habitual user of a narcotic,

barbiturate, amphetamine, hallucinogen, or

other drug having similar effects;

HRS § 453-8(a)(7): Professional misconduct, hazardous

negligence causing bodily injury to another, or

manifest incapacity in the practice of medicine, osteopathy, or surgery;

HRS § 453-8(a)(9): Conduct or practice contrary to the

recognized standards ethics of the medical profession as adopted by the Hawaii Medical

Association, the American Medical Association, the Hawaii Association of Osteopathic Physicians and Surgeon, or the American Osteopathic Association; and

HRS § 436B-19(17): Violating this chapter, the applicable licensing

laws, or any rule or order of the licensing

authority.

Based on the foregoing, the Board imposed the following conditions to Dr. Schaefer's conditional license:

1. Dr. Schaefer shall, at his sole expense, enter into a monitoring contract with Pu`ulu Lapa`au, Hawaii Program

for Healthcare Professionals ("Pu`ulu Lapa`au"). Dr. Schaefer is to provide the Board's Executive Officer a copy of the fully executed contract within ten (10) days of his agreement becoming effective. The length of the monitoring contract shall be determined by Pu`ulu Lapa`au. During the period of the contract Dr. Schaefer shall refrain from using drugs, except as provided by his treating physician, or alcohol. He shall provide a copy of this letter to the Program Director of Pu`ulu Lapa`au for its records. In turn, Pu`ulu Lapa`au shall send regular reports to the Board regarding Dr. Schaefer's compliance.

- 2. If at any time Pu`ulu Lapa`au determines that Dr. Schaefer is not in compliance with the monitoring contract, he shall immediately notify the Board and immediately cease practicing osteopathic medicine until Pu`ulu Lapa`au specifies to the Board what conditions, if any, it recommends for Dr. Schaefer to safely resume the practice of medicine. Depending upon Pu`ulu Lapa`au's written report and recommendations, the Board may evaluate, what, if any, further conditions are warranted for Dr. Schaefer to practice osteopathic medicine and impose such conditions on his license. If Dr. Schaefer fails to refrain from using drugs or alcohol, the Board also will consider whether to suspend, revoke, or otherwise discipline his license.
- 3. Should Dr. Schaefer wish to have any condition removed from his license he shall make a request in writing to the Board, at which time the Board would consider his request. When doing so, Dr. Schaefer shall provide evidence of full compliance with his monitoring contract with Pu`ulu Lapa`au.

Jason H. Habu, EMT-P

It was moved by Dr. Barrickman, seconded by Dr. Kosasa and unanimously carried to approve Mr. Habu's application for licensure.

<u>Unfinished Business:</u> a. <u>Rules Revisions: PA Provisions</u>

Executive Officer Cabral advised the Board that the Ad Hoc Committee on the PA Rules Revisions met today prior to the Board meeting. Dr. Desai presented the committee's recommendations regarding the review of medical records. Specifically, (b)(2) should

be changed from new supervisory physician or osteopathic physician to new employment:

§16-85-49.3 Medical Records Review. (a) Each physician assistant and supervising physician or osteopathic physician shall establish written guidelines for the review of medical records as appropriate to the specific practice. These guidelines must be kept in the office of the practice setting in which either the physician assistant or supervising physician or osteopathic physician practices, and shall be available to the Hawaii Medical Board and/or the Regulated Industries Complaints Office or their designee.

- (b) The supervising physician or osteopathic physician shall review medical records as required below, provided that the supervising physician or osteopathic physician shall review all medical records that contain written orders or prescriptions for controlled substances.
 - (1) When supervising a Category 1 Physician Assistant:
 - (A) For the first 6 months of supervision, review and sign 100% of the medical records within 7 days of the patient visit; and
 - (B) For the next 6 months of supervision, review and sign 50% of the medical records within 7 days of the patient visit.
 - (2) Category 1 Physician Assistants are those who:
 - (A) are newly licensed in Hawaii;
 - (B) have a new supervisory physician or osteopathic physician new employment; or
 - (C) started a new practice specialty.
 - (3) When supervising a Category 2 Physician Assistant:
 - (A) Review and sign 10% of the medical records within 30 days of the patient visit; or
 - (B) For at least 30 minutes each month, perform an audit and review and sign medical records.
 - (4) Category 2 Physician Assistants are those who have atisfactorily completed Category

1.

(c) Notwithstanding section (b) above, a supervisory physician or osteopathic physician may require additional supervisory requirements at anytime for patient safety.

New Business: a. <u>Legislation:</u>

S.B. No. 548, S.D.1, relating to telemedicine

The Board has no objections to this bill since the scope of exemption has been limited to commissioned medical officers employed by the United States Department of Defense who are credentialed by Tripler Army Medical Center.

S.B. No. 655, S.D.2, relating to health

The Board supports the intent of this bill.
