Unfinished Business: a. Rules Revisions: PA Provisions

For informational purposes, Executive Officer Cabral distributed to the Board the materials that Vince Tenorio shared with the Board at the December 2012 Board meeting.

Mr. Tenorio reported that the Hawaii Academy of Physician Assistants ("HAPA") is requesting that the matter relating to medical records review and controlled substance class 2 be deferred for further consideration. Mr. Tenorio advised the Board that HAPA is querying supervising physicians on their position regarding these matters.

New Business: a. Legislation:

S.B. No. 548, S.D.1, relating to telemedicine

Executive Officer Cabral informed the Board that this Bill is scheduled to go before the Conference Committee.

S.B. No. 655, S.D.2, HD 2, relating to health

The purpose of this bill is to protect public health by allowing health care professionals to dispense or prescribe medication, without examination, to the partners of patients diagnosed with a sexually transmitted disease, in accordance with the recommendations of the Centers of Disease Control and Prevention of Expedited Partner Therapy.

While the Board recognizes the benefits of expedited partner therapy, it has some concerns with this bill. The Board notes that because the Board's primary function as a regulatory board is to protect consumers through implementation of the applicable licensing law and rules, its focus relates primarily to licensing qualified physicians, disciplining those who do not comply with the Board's statutes and rules , and providing information about specific board actions and interpretations that may impact licensee conduct. This being the case, the Board sees expedited partner therapy as a public health issue and, therefore, not within the Board's jurisdiction.

The Board is also concerned that physicians will be able to prescribe or dispense antibiotic therapy to their patients' partners without examining those partners. The Board believes an examination should be performed in light of potential drug interactions and adverse reactions.
