#### Cynthia J. Provow, M.D.

The Board reviewed and considered the records and files of Dr. Provow's application and the information received from him as well as from other organizations, including but not limited to: 1) Dr.

Provow's statement of explanation dated March 14, 2013; 2) the National Practitioner Data Bank ("NPDB") Medical Malpractice Payment Report; and 3) the NPDB Title IV Clinical Privileges Action Report.

After due consideration of the information received, it was moved by Dr. Kosasa, seconded by Dr. Barrickman and unanimously carried to deny Dr. Provow's application for licensure, basing its decision on the following legal grounds of the Hawaii Revised Statutes ("HRS"), which find factual support in the records and files of Dr. Provow's application:

HRS § 453-8(a)(7): Professional misconduct, hazardous

negligence causing bodily injury to another, or

manifest incapacity in the practice of medicine, osteopathy, or surgery;

HRS § 453-8(a)(8): Incompetence or multiple instances of

negligence, including but not limited to the consistent use of medical service, which is

inappropriate or unnecessary;

HRS § 453-8(a)(9): Conduct or practice contrary to the

recognized standards of ethics of the medical

profession as adopted by the Hawaii Medical

Association, the American Medical Association, the Hawaii Association of Osteopathic Physician or Surgeons, or the American Osteopathic Association; and

HRS § 436B-19(8): Failure to maintain a record or history of

competency, trustworthiness, fair dealing, and

financial integrity.

#### <u>Unfinished Business:</u> a. <u>Rules Revisions: PA Provisions</u>

The Boards received letters from various supervising physicians in support of amending the PA rules relating to medical records review and class 2 controlled substances.

The Ad Hoc Committee on PA Rules Revisions met today prior to the Board meeting. Members of the committee briefed the Board on their recommendations in amending the PA rules.

Discussion followed. It was moved by Dr. Akaka, seconded by Dr. Desai that the supervising physician or osteopathic physician shall

review medical records as required below, provided that the supervising physician or osteopathic physician shall review all medical records that contain written orders or prescriptions for controlled substances.

- (1) When supervising a Category 1 Physician Assistant:
  - (A) For the first 6 months of supervision, review and sign 100% of the medical records within 7 days of the patient visit; and
  - (B) For the next 6 months of supervision, review and sign 50% of the medical records within 7 days of the patient visit.
- (2) When supervising a Category 2 Physician Assistant:
  - (A) Review and sign 10% of the medical records within 30 days of the patient visit; or
  - (B) For at least 30 minutes each month, perform an audit and review and sign medical records.
