<u>New Business</u>: a. <u>Rules Revisions</u>: <u>Emergency Medical Technician-Basic</u>

Executive Officer Cabral related to members that the Department of Health ("DOH") has requested further changes to the rule revisions.

Dr. Desai indicated that Dr. Rosen's letter was not clear and requested that Executive Officer Cabral provide a fact sheet listing the course of events and actions that were taken by the various committees.

b. License Verifications

Members reviewed a letter dated May 2, 2013 from Dr. Rodney Bjordahl, Chief Medical Officer, Maui Memorial Medical Center regarding telemedicine license delays.

Dr. Bjordahl proposes the following two options:

- 1. Require a letter from a Joint Commission certified entity that the physician is in good standing with all hospitals that the physician is affiliated with, or
- 2. Require primary verification of a random 30% portion of the affiliated hospitals.

This matter was previously discussed at its November 8, 2012 meeting in which it was determined that the Board does not have the discretion to waive or modify its administrative rule requirement pursuant to §16-85-7(a)(1), Hawaii Administrative Rules, which states that an applicant shall provide:

"Evaluation reports relating to the applicant's conduct and competency from every hospital at which the applicant has applied for or held consultation or teaching appointments or privileges or has been employed in a residency program within the immediate three years preceding the application."

After further discussion, the Board opined again that, absent a formal rule change pursuant to the rulemaking process set forth in chapter 91, Hawaii Revised Statutes, it does not have the discretion to waive or modify its administrative rule requirement.
