Bharat K. Narumanchi, M.D.

After due consideration of the information received and Dr. Narumanchi's oral testimony, it was moved by Dr. Desai, seconded by Dr. Bintliff and unanimously carried to defer Dr. Narumanchi's application pending receipt of additional information and review.

In particular, the Board requests that a letter be sent to Richard Kynion, M.D., Program Director, Tripler Army Medical Center, Pediatric Residency Program. This letter should request copies of Dr. Narumanchi's resident evaluations as well as all materials relating to his competency and ability to practice pediatric medicine. Dr. Kynion is also to explain the discrepancy between the information he provided and Dr. Narumanchi's oral testimony.

Furthermore, the Board would like to advise Dr. Kynion of the importance of the Program and its Director to provide accurate and honest information at all times to enable the Board to make appropriate and informed decisions. Failure to complete and submit accurate Board forms may constitute a violation of § 710-1017, HRS, which states in relevant part that:

A person commits the offense of tampering with a government record if:

- (c) The person knowingly records, registers, or files or offers recordation, registration, or filing in a governmental office or agency, a written statement which has been falsely made, completed, or altered in which a false entry has been made, or which contains a false statement or false information.

Steven A. Newman, M.D.

After due consideration of the information received and Dr. Newman's oral testimony, it was moved by Chair Takanishi, seconded by Dr. Kosasa, with Dr. Akaka recusing himself, and carried by majority to approve Dr. Newman's application for licensure subject to certain conditions, basing its decision on HRS §§ 436B-19(5), 436B-19(7), 436B-19(8), and 436B-19(9).

Based on the foregoing, the Board hereby issues Dr. Newman a conditional license limited to practice medicine in the specialty of Diagnostic Radiology and subspecialty of Neuroradiology. This limitation shall not preclude Dr. Newman from performing any and/all procedures associated with Diagnostic Radiology and Neuroradiology.

Dr. Newman shall provide a copy of the conditional letter to his employer and any hospitals with which he seek privileges within ten (10) days of the start of his employment. In turn, Dr. Newman's employer shall send written confirmation to the Board's Executive Officer confirming receipt of the letter.

Should Dr. Newman wish to have any condition removed from his license, Dr. Newman shall make a request in writing to the Board, at which time the Board would consider his request. When doing so, Dr. Newman shall provide evidence of full compliance with the conditions.

- c. Hawaii's Healthcare Workforce 20/20 Plan and Report:
Barriers 10, 11 and 12

The Board reviewed the Legislative and Regulatory Barriers to Hiring. Executive Officer Cabral explained to the Board that the Licensing Administrator is seeking the Board's comments regarding Barriers 10, 11 and 12.

Discussion followed. Members indicated that the resolutions proposed for Barriers #10, #11, and #12 of the report are acceptable.

With regard to Barrier #12, Chair Takanishi indicated that the Board is in the process of drafting rules that will:

1. Increase the number of PA that a physician may supervise from to 2 for 4;
2. Gradually decrease the number of medical records a physician must review depending upon the length of time the physician has supervised the PA. (For instance, the physician would review 100% of the medical records for newly hired PAs, 50% of

the records after 6 months and 10% of the records 6 months after that.); and

3. Allow PAs to prescribe schedule II controlled substances.
