Upon a motion by Mr. Touchi, seconded by Mr. Chung, it was unanimously carried to ratify the above lists for the licenses sought (as attached).

Correspondence:

<u>U.S. Customs and Border Protection – "Potential Indicators of Terrorist/Criminal Activity Related to Mass Transportation";</u> "Terrorism, What Can I Do To Help?"

Informational material received from the U.S. Customs and Border Protection Task Force regarding the prevention of terrorists and terrorist attacks was provided to members for their information. The material was sent to the Board on the basis that it was identified as a major transportation provider and/or related to an airport service provider in the State of Hawaii.

The Executive Officer stated that she responded to the Task Force informing the Task Force that the Board is not a transportation provider; that it does not transport vehicles, but oversees the regulatory scheme that governs the activities of motor vehicle auctions, manufacturers, distributors, dealers, salespersons and consumer consultants. It was determined that no Board action is necessary.

#### **New Business:**

# Request from Servco Regarding Whether Their Proposed Website Requires a License

In a letter dated November 8, 2011, Servco requested the Board to review its proposed website, and determine whether a motor vehicle dealer license is required. The letter explains that Servco is in the process of establishing a website for its customers who are seeking to purchase a pre-owned motor vehicle. The website is a consolidation of the inventories of all of Servco's dealerships. The customer will visit the website to find the car the customer wants and the website will direct the customer to the specific dealership which has the vehicle the customer wants. No sales transactions will take place on the website. All sales transactions will take place at the dealerships.

After a brief discussion, it was moved by Mr. Masamitsu, seconded by Mr. Touchi, and unanimously carried to issue the following informal interpretation that based on the information presented by Servco and the understanding that (1) Servco currently holds a dealer's license; (2) inventories from all Servco's dealerships will be consolidated to this one website; (3) no sales transactions will be conducted on the website; and (4) no advertising will take place on the website, a separate motor vehicle dealer's license is not required.

The informal interpretation is being provided for informational and explanatory purposes only and is not an official opinion or decision, and therefore is not to be viewed as binding on the Board or Department. Should a formal determination be desired, a petition for declaratory ruling must be filed pursuant to chapter 16-201, Hawaii Administrative Rules.

In the Matter of Soderholm Sales and Leasing, Inc., Petitioner vs. City and County of Honolulu, Department of Budget and Fiscal Services, Respondents; PCH-2011-10

This matter concerns the purchase of paratransit vehicles by the City and County of Honolulu. Issues regarding the successful bidder and its manufacturer lacking Hawaii licenses were raised by Soderholm Sales and Leasing Inc. Copies of documents concerning this matter were given to members for their information. Denise Soderholm informed the Board that the case has been concluded and is awaiting the decision from the Office of Administrative Hearings, DCCA.

November 16, 2011 Letter from Denise L. Soderholm, President, Soderholm Sales & Leasing, Inc. Regarding National Bus Sales and Leasing, Inc., Champion Bus, Inc., BusWest Motor Vehicle Dealer Activity/License Requirement

In a letter dated November 16, 2011, Denise Soderholm of Soderholm Sales & Leasing, Inc. asked the following questions of the Board:

 Soderholm informed the Board that they have filed a lawsuit in the U.S. District Court against National Bus Sales & Leasing, Inc. ("National) and Champion Bus, Inc. ("Champion") because they are illegally selling buses in Hawaii without a license.

Soderholm is requesting the Board to not issue a license to either National Bus Sales and Leasing, Inc. or Champion Bus, Inc. until after the hearing scheduled for January 30, 2012.

There was discussion about the license application process and issuance of licenses. There was also discussion about Soderholm's allegations that National and Champion are engaged in unlicensed motor vehicle dealer activity. The Executive Officer informed Denise Soderholm that the allegations should be filed with RICO, as a complaint. Denise Soderholm stated that she has filed complaints with RICO and that actions are either not taken or RICO takes too long to act. Denise Soderholm was informed that any concerns they may have about RICO needs to be taken up with RICO because the Board has no authority over RICO.

 Soderholm wants to know why the Board did not intervene in their appeal to the City's denial of their protest of the Handi-Van bid.
 Soderholm believes the Board should have defended HRS Chap. 437, and taken a more proactive role in the matter.

DAG Tam stated that the Office of Administrative Hearings shared a courtesy copy of their appeal on the procurement matter with the Board. Their matter, which involved a bid protest, is not within the Board's jurisdiction. Erik Solderholm emphatically stated that the matter did involve the Board because the competitive bidder did not have a Hawaii license. He added that the Board should defend chapter 437, it is the Board's duty to uphold the law. DAG Tam stated that the Board's position that anyone engaging in motor vehicle dealer activity in Hawaii is required to meet Hawaii's licensure requirements and be licensed in Hawaii before it can engage in the activity, in this State, is clear. DAG Tam also said that Solderholm's dispute with the City regarding Federal funding or grants is not within the Board's jurisdiction.

#### 3. BusWest

Soderholm objects to the Board approving BusWest's application for a motor vehicle dealer's license. Denise Soderholm stated that chap 437 allows the Board to deny the issuance of a license and wants to know why the Board did not exercise its right in this situation. There have been numerous complaints filed against BusWest with RICO concerning unlicensed activity by BusWest.

The Executive Officer reiterated the earlier discussion about the license application process and their allegations that BusWest engaged in unlicensed activity. The Executive Officer stated that their concerns regarding the unlicensed activity need to be taken up with RICO; that RICO is charged with authority to pursue unlicensed activity.

DAG Tam asked Denise Solderholm to explain what she meant by the following: "The (DAG) went on to say that the RICO complaints took too long to resolve." Denise Solderholm stated that she meant that the DAG seemed to be sympathetic to their situation. She stated that the DAG did not actually state that RICO took too long to resolve complaints; she corrected her statement.

#### July 1, 2012 Board Member Vacancies

The Executive Officer reported that the terms for Messrs. Nakama, Chung and Touchi will expire on June 30, 2012 – 1 industry and 2 public vacancies. The Executive Officer also reported that although the terms for Messrs. Chung and Touchi expire on June 30<sup>th</sup>, Mr. Chung is eligible to serve another 3 years, and Mr. Touchi, another year. The Executive Officer asked Mr. Chung and Mr. Touchi if they are willing to continue serving on the Board. They both said they would think about it and let the Executive Officer know. The Executive Officer also informed the Board that the industry vacancy may be filled by anyone who is engaged in the motor vehicle industry, both franchise dealers and independent dealers.

### 2012 Legislative Session

There was discussion on the Board's legislative delegate for the 2012 legislative session. Board members briefly discussed the upcoming legislative session and the possibility that Board input may be required on bills that could impact the Board's program of work. The Board further discussed the logistics involved in convening a meeting, establishing a quorum of members, the requirement to file an agenda, etc., and the impact on the Board's ability to deliver its comments in a timely manner.

After discussion, it was moved by Mr. Short, seconded by Mr. Touchi, and unanimously carried to delegate authority to Chairperson Uhmbau to take the lead in legislative matters, including testifying on behalf of the Board as needed.

Mr. John Gillmor, attorney for HIADA, appeared before the Board to share with the Board HIADA's proposed legislation. This matter was not on the agenda. After a brief discussion, it was moved by Mr. Touchi, seconded by Mr. Johnson, and unanimously carried to add HIADA's proposed bill as an item on today's agenda.

Mr. Gillmor provided members with copies of HIADA's proposed legislation. Mr. Gillmor explained that HIADA's proposed legislation deals with (1) adding the state taxation law regarding certain motor vehicle transactions, and (2) amending sections 437-7, 437-11, 437-18 and 437-29 as well as adding a new section relating to motor vehicle dealers.

The purpose of amending the sections in (2), above, is to update dealer bonding requirements and to clarify the Board's authority to impose a bond in certain cases of dealer misconduct. The bill also makes explicit the requirement that dealers provide no fault coverage on vehicles and that the dealer's sales location must be zoned for such use. Chairperson Umbhau asked if there were any questions. Chairperson Umbhau thanked Mr. Gillmor.

Dave Rolf thanked the Board members for their continuing support of HADA. Dave Rolf mentioned that he met with John Gillmor to discuss HIADA's two concerns.

With regard to HADA's position on a request received from Sendmeafriend.com, an online auto referral program (see minutes of June 21, 2011), Dave Rolf reported that HADA has no position on the referral program.
