Chapter 91, HRS Adjudicatory Matters:

The Chairperson called for a recess from the meeting at 9:18 a.m. to deliberate on the following adjudicatory matter, pursuant to Hawaii Revised Statutes ("HRS") Chapter 91.

In the Matter of the Motor Vehicle Salesperson's License of SEAN K. ORNELLAS, Respondent; MVI 2012-38-L - Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order

Deputy Attorney General Tam summarized the above matter and a brief discussion followed.

After discussion, it was moved by Mr. Johnsen, seconded by Mr. van den Hurk, and unanimously carried to approve the settlement agreement in which:

- 1. Respondent does not admit to violating any law or rule. Respondent enters into this settlement strictly as a compromise and in order to conserve on the expense of proceeding with an administrative hearing.
- 2. Respondent agrees to the voluntary surrender of Respondent's license, which shall become effective immediately upon the Board's approval of the Settlement Agreement. Respondent understands that Respondent cannot apply for a new license until the expiration of at least five (5) years from the effective date of the license. Respondent understands that if Respondent desires to become licensed again, Respondent must apply to the Board for a new license, pursuant to and subject to all applicable laws and rules in effect at the time.

At 9:22 a.m., it was moved by Mr. Touchi, seconded by Mr. Chung, and unanimously carried to enter into Executive Session to consider and evaluate personal information relating to the individual applying for licensure in accordance with Chapter 92-5(a) (1), and to consult with the Board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities in accordance with Chapter 92-5(a) (4), Hawaii Revised Statutes.

New Business: 2013 Legislative Session

S.B. No. 618, Relating to the Motor Vehicle Industry Licensing Act H.B. No. 572, Relating to the Motor Vehicle Industry Licensing Act

The Executive Officer reported that S.B. No. 618 was not scheduled for hearing; therefore, the bill is done for the session.

The Executive Officer reported that H.B. No. 572 was heard on February 8, 2013 by the House Committee on Transportation which deferred the measure. Therefore, this bill is done for the session. As information, this bill is the same bill that was introduced last session.

GM 610 – Don Touchi GM 517 – William van den Hurk

Confirmation hearings are scheduled for Wednesday, February 27, 2013. Mr. Touchi, who is currently serving as a holdover, is up for reappointment. Mr. van den Hurk, who is currently serving on an interim basis, is up for appointment.

The Executive Officer reported that RICO filed actions for consent judgments against various motor vehicle dealers for unlicensed activity. The court ordered that the dealers pay a fine and not engage in the business until it obtains a license. Board members were provided copies

of the court documents for their information. A list of these actions can be viewed at www.hawaii.gov/dcca/rico.

HIADA:

Kimo Pierce stated that recently HIADA experienced a change in officers. He related that he will now be HIADA's legislative liaison with the Board. On behalf of HIADA, he apologized to the Board for not first approaching the Board with its 2013 legislative initiative. He stated that HIADA understands the need to work with both HADA and the Board so that the parties are on the same page and can address one another's concerns. He stated that HIADA wants to move forward and begin working on an initiative for 2014.

Mr. Pierce stated that HIADA wants to address the following:

Premises of used car dealers. He cited to the lack of pre-license inspections that result in some dealers doing MVD activity from non-conforming sites, such as Waikiki district and agriculture land. He said that before a law change, all MVD's were required to have the dealerships inspected. He added that HIADA understands the State's concerns with funding and resources.

Mr. Azad Tirgardoon stated checking the Waikiki district is so easy and since Mr. Pierce would be willing to provide a map, DCCA can easily check the map for the address.

Mr. Pierce was asked if he would be present at the Board meetings regarding discussions on legislative issues and he responded that yes he would be in attendance.

Other issues discussed dealt with liability insurance for new and used car dealers, zoning, increase in fees for applications for licenses and renewals, and increasing the value of the bond to \$100,000.

Chair Umbhau stated that the HADA and HIADA must work together and work towards the impact on the Board, industry and consumers.

Mr. van den Hurk volunteered to work with HIADA/HADA on proposed legislation for 2014, and present the proposals to the Board for review and discussion.

Dave Rolf expressed concerns regarding H.B. 189 and S.B. 1295, relating to gender equity on boards and commissions and its effect on the Industry Board. The bills propose equal gender representation when nominating and appointing members to a board or commission.
