The Executive Officer stated that today was Mr. Chung's last meeting as his term expires on June 30, 2013. Mr. Chung has served on the Board for eight consecutive years. She expressed her gratitude and thanks for

his contributions to the Board.

Upon a motion by Mr. Chung, seconded by Mr. Touchi, it was unanimously carried to ratify the above lists for the licenses sought (as attached).

Chair Umbhau informed the members that the agenda would be taken out of order.

<u>Unfinished</u> Business:

Email request from Erik Soderholm regarding HRS 437 requirement that the Department or Director has the right to grant a motor vehicle dealer, franchise or motor vehicle manufacturer license prior to a vote from the Board – Deferred from April 16, 2013 Meeting

Denise Soderholm appeared before the Board along with her attorney, Jeff Miller. Ms. Soderholm said that Erik Soderholm was not available for today's meeting. Ms. Soderholm asked why the license applications

> for manufacturers/distributors are approved at the staff level and not by the Board at a Board meeting. They do not object to the processing of the applications, but object to approvals being handled at the staff level.

The Executive Officer stated that this matter was deferred from the April 16, 2013 meeting and gave a brief summary of the discussion with with Erik Soderholm at the last meeting. Deputy Attorney General Tam stated that he would review the matter and report back at today's meeting.

Deputy Attorney General Tam read out loud §437-7(f)(1) through (5), HRS.

Deputy Attorney General Tam also cited to §436B-8, HRS, regarding the Board's delegation of authority to the Executive Officer to perform ministerial functions. It has been the Board's practice to delegate the ministerial functions to the Executive Officer. He said that the manufacturer and distributor requirements for licensure are ministerial. Mr. Miller stated that he did not agree and will consider taking up this matter in the future.

Upon a motion by Mr. Touchi and seconded by Mr. Johnsen, it was unanimously carried to delegate to the Executive Officer the authority to approve all license applications for manufacturers and distributors as long as all requirements have been satisfied.

At this time of the meeting, Mr. Cerizo presented a volume of documents for the Board members to review. Several members stated that there were too many documents to be reviewed in such a short time. In fairness to Mr. Cerizo and to provide the members sufficient time to review the documents and after a brief discussion, it was moved by Mr. Touchi, seconded by Mr. Short, and unanimously carried to defer the review of Mr. Cerizo's application until the next meeting upon receipt of additional information.

New Business: April 16, 2013 Email Request from Erik Soderholm Regarding

(1) <u>Discussion regarding whether Board's Executive Officer has no</u>
<u>authority to approve motor vehicle manufacturer license applications</u>
<u>and motor vehicle manufacturer license applications shall be</u>
conducted in open session as per State Sunshine law

Mr. Soderholm is asserting that the Board cannot have closed meetings because no personal matters are discussed.

§§ 92-4 and 92-5, HRS, state that "... A board may hold a meeting closed to the public pursuant to section 92-4 for one or more of the following purposes: ...".

(2) All license applications for motor vehicle salespersons, dealers, auction and manufacturers must be on agenda to comply with State Sunshine law

Mr. Soderholm is concerned with the ratification ("RAT") list.
Mr. Soderholm is requesting that all the names on the RAT list be listed on the agenda or if not, then attached to the agenda.
Mr. Soderholm believes that the public should know who the applicants are in the event there are questions concerning the individual(s) on the list; the public should be able to give input on the applicants, then the issues can be addressed. The list is not available to the public until after the fact. Mr. Soderholm asked whether the Board was in compliance with the Sunshine law. Deputy Attorney General Tam stated that he will look into this.

By consensus, it was agreed to defer this matter until the next meeting.

(3) Board is wrong to allow the City to buy directly from an unlicensed mainland motor vehicle manufacturer

The Executive Officer stated that the Board previously discussed this matter and is recorded in its September 4, 2012 meeting minutes.

Board members commented that as stated previously, the Board does not have authority over procurement code issues.

Dave Rolf, HADA, had no report for the Board, also thanked Mr. Chung for his years of service as a member.

Kimo Pierce, HIADA, had no report for the Board.

The Executive Officer asked both Dave Rolf and Kimo Pierce if HADA and HIADA will be submitting names to the Governor's Office to fill the industry member vacancy. Dave Rolf stated that HADA will be submitting Wayne DeLuz' name and Kimo Pierce stated that HIADA will try to submit a name.
