April 4, 2013 Meeting

Ms. Stone made the following recommendations:

Regular meeting minutes

On page 2, under Chair's Report, the last sentence under the first bullet, last sentence, add a coma after "patients" and a coma after "future" and the second sentence of the eight bullet, insert a period after "education" and start a new sentence beginning with "The number...".

Executive session minutes

On page 2, the first sentence, replace "he burden of proof" with "that her license is unencumbered".

There being no further amendments, upon a motion by the Vice Chair, seconded by Ms. Stone Murai, it was voted on and unanimously carried to approve the minutes of the April 4, 2013 meeting as amended.

February 7, 2013 Meeting

The Chair reported that there is a discrepancy between the language in the minutes on page 8 of the February 7, 2013 meeting and the language in the letter that was sent to applicant Miki Villaverde.

After some discussion, the Board determined that language in the minutes were incorrect and should be amended to read as follows: "deny the following application pursuant to §436 B-19(9), (12) & (14)".

There being no further corrections, upon a motion by the Vice Chair, seconded by Ms. Cohen, it was voted on and unanimously carried to amend the minutes of the February 7, 2013 meeting.

Chair's Report:

The Chair reported on his attendance at the 2013 APRN Roundtable, April 9, 2013, Chicago, Illinois.

The Chair stated it was a good meeting and there was a lot of discussion on the APRN consensus model. He stated that there was also discussion on title and title protection and the use of the term "doctor" for DNPs..

Conferences/Seminars/Meetings

NCSBN 2013 Long Term Care Conference, April 16-17, 2013

Mr. Hoban reported on his attendance at the NCSBN 2013 Long Term Care Conference, April 16-17, 2013, in San Diego, California.

He stated that the conference was well organized and interesting. One of the main topics of discussion was the delegation of authority in long term care facilities and the responsibilities of RN's within the facility.

NCSBN 2013 IT Conference, May 23-24, 2013

The Vice Chair and Dr. Kula will be attending, and will be meeting with PVL's IT person immediately following today's Board meeting.

NCSBN Discipline Conference, June 5-7, 2013

The EO reported that the DAG is unable to attend. The EO recommended that the Regulated Industries Complaints Office send someone to this conference.

2013 NCLEX Conference, September 9, 2013

The EO reported that the 2013 NCLEX Conference will be held on September 9, 2013 in Chicago, Illinois and asked the Vice Chair to explain the benefits of this one day conference.

The Vice Chair stated the conference is mostly for educators.

Ms. Fleming and Ms. Cohen are interested in attending.

Correspondence

Nurse Practitioners (NP) Applying Fluoride Varnish

The Board discussed an email inquiry from an APRN working out of a Federally Qualified Health Center regarding a federal grant they were awarded to screen and apply fluoride varnish to Hawaii's school children.

The EO stated that she asked the EO for the Hawaii Medical Board ("HMB") if this would be considered medical practice, and the HMB's response was yes.

Ms. Stone Murai stated this grant is something that is happening all over the country and is not unique to Hawaii.

The Vice Chair stated that HAR §16-89-81 describes the scope of practice for the APRN and that if the APRN has received the appropriate training, they may be able to perform such an activity.

The Chair asked how the nurse will provide proof that she has the education and training to apply this.

The EO pointed out in the email, the nurse states she has received training to do an advanced assessment of oral health and to apply the varnish.

The Chair stated, saying you have training and providing evidence of that training is two different things. The nurse must be able to provide proof of that training should they be questioned.

Executive Session:

At 9:17 a.m., upon a motion by Dr. Kula, seconded by the Vice Chair it was voted on and unanimously carried to move into Executive Session in accordance with HRS, 92-5(a) (1) and (4), "To consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section 26-9 or both;" and "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities".

At 9:37 a.m., upon a motion by the Vice Chair, seconded by Dr. Fleming, it was voted on and unanimously carried to move out of executive session.

The Chair stated that the APRN should speak with the Medical Director of the Health Center.

Ms. Stone Murai stated that HRS §457-1.5 also describes the "practice of nursing" and that HRS §457-8.5 and 457-8.6 also describes the practice of an APRN.

After some discussion, upon a motion by Dr. Kula, seconded by Mr. Hoban, it was voted on and unanimously carried that it is the Board's informal interpretation to refer the

inquirer to HRS §§ 457-1.5, 457-8.5, 457-8 and HAR 16-89-81 and also to the Medical Director of the health center.

National Council of State Boards of Nursing (NCSBN)

Participation in NURSYS

Department of Veterans Affairs – APRN Practice

The Board reviewed the April 2, 2013 letter from the Department of Veterans Affairs regarding their pursuit of a national policy to recognize the full practice of all VA APRNs and the ability of VA nurses to use protocols in the delivery of patient care.

The Chair stated that every state has a VA and every VA requires that a nurse hold a license in a state. Should action be taken against a nurse, it would come under the state that the nurse holds a license.

Dr. Fleming stated that the state board of nursing that issued the license is responsible for the conduct of the nurse, not the state where the nurse is currently employed by the VA.

There was no further discussion.
