- Call to Order: The Chair called the meeting to order at 9:35 a.m. at which time quorum was established.
- The Chair excused Dr. Kula and Mr. Hoban from today's meeting.
- Approval of the Agenda: The Chair called for a motion for today's agenda. There being no additions or additional distribution, upon a motion by Ms. Stone Murai, seconded by the Vice Chair, it was voted on and unanimously carried to approve the agenda as circulated.
- Approval of the Minutes: The Chair called for a motion in regards to the minutes of the July 7, 2011 meeting.
- Ms. Stone Murai stated that the response to the inquiry regarding RN's initiating, ebolus and maintain the PC pump following epidural placement appears to be vague and that explains why these inquiries keep coming back to the Board. She stated that the "boiler plate" response does not appear to offer any guidance and the Board's response should be more descriptive and helpful.

The Chair responded that these inquiries are one-sided, meaning the inquirer is normally asking about a specific procedure as it relates to the institution or facility they are employed by and that the Board's response is generalized since we have not considered the institution or facility's position.

The EO informed the Board that when considering inquiries, the Board can provide a response that is based solely on the information provided by the inquirer and based on the applicable laws and rules, may come up with an "informal interpretation" that is provided for informational and explanatory purposes only and is not an official opinion or decision and therefore is not to be viewed as binding on the Board.

The DAG recommended the following amendments to the minutes:

On page 5, second paragraph under "Midwife Licensing", the sentence should read as follows:

"The Board determined that a nurse-midwife falls under an Advanced Practice Registered Nurse and that "midwives" **who** are not nurses do not fall under the Board's authority."

On page 5, second to the last paragraph under "Can an LPN Practice IV Therapy, Dialysis or Venipuncture?", the word "**be**" should be included after the word "should" on the second to the last line.

On page 6, under "Advanced Practice Registered Nurse (APRN)" for Dawn Ferguson, in regards to her MSN curriculum, it should state "**her**" instead of "the" in the second to the last line.

There being no further amendments to the minutes, upon a motion by Ms. Cohen, seconded by the Vice Chair, it was voted on and unanimously carried to approve the minutes of the July 7, 2011 meeting as amended.

The Chair called for a motion in regards to the Executive Session minutes of the July 7, 2011 meeting.

The DAG recommended the following amendment to the Executive Session minutes:

On page 2, under Applicants, Carol Gutierrez, second paragraph, it should read as follows:

"they ~~denied~~ **recommended** her...."

There being no further amendments to the Executive Session minutes, upon a motion by Ms. Cohen, seconded by the Vice Chair, it was voted on and unanimously carried to approve the Executive Session minutes of the July 7, 2011 meeting as amended.

The EO asked Ms. Matsumoto to provide a verbal report on the availability of the meeting minutes on the Board's web page.

Ms. Matsumoto reported that starting with the July 2011 minutes, the Board meeting minutes will be available to the public and posted on the Board's web page upon approval of the minutes by the Board.

Chair's Report: None.

Vice Chair's Report: The Vice Chair and Ms. Elvenia provided a brief verbal report on their attendance at the NCSBN Annual Meeting. Some of the topics discussed included uniform license requirements, future consideration of MEPN program students not being eligible to sit for the NCLEX-RN, sex offenders/predators convictions and the denial of the nurse license, letters to employers of Board members, "Just culture", guidelines for substance abuse, "medication aides" vs. LPNs, and accredited nursing programs.

Executive Officers **2011 Legislation**

Report:

The EO reported on the following:

Resolutions Relating to Palliative Care – HR 48/HCR 55, Requesting the Development and Implementation (By the Board of Nursing) of a Pain and Palliative Care Policy

She is preparing the report to the Legislature and would like to pass it through to the Practice Committee for their consideration/recommendations at their September meeting and then eventually to the Board for approval before it is submitted to the Legislature.

Draft #3 – Summary of Act 110, SLH 2011

The EO asked the members if they had any comments/recommendations to the draft that was submitted that summarized Act 110, SLH 2011. The Chair stated that he submitted his recommendations to the Hawaii Center for Nursing ("Center"). The EO asked the other members if they had any recommendations.

After some discussion, the Board members wanted one week to review and get back to the EO so that she can send one response to the Center.

Conferences/Meetings/Seminars

Fall 2011 Member Board Review of Newly Developed Items and/or Simulated Examinations, October 12, -31, 2011

The EO recommended that the Board member who wishes to participate in this review not be an instructor or be connected or affiliated with any nursing program.

The Board requested more information and clarification from the NCSBN for this review.

Education Committee
Report:

Ms. Cohen reported that at the July 7, 2011 meeting, the committee discussed the following:

Review and Consideration of Proposed Revisions to the Annual Report Form

The Committee made further amendments with the recommendation to finalize the annual report form for the Board's consideration at the August meeting.

Consideration of a Uniform Quarterly Report Form

The Committee considered a draft of a quarterly report form, drafted by the Vice Chair to be used by a Board approved nursing program whose passing rate falls below 90% of the national average.

Ms. Cohen also announced that the Education Committee will be meeting after the Board meeting today.

Upon a motion by Ms. Cohen, seconded by Ms. Stone Murai, it was voted on and unanimously carried to accept the report of the Education Committee's July 7, 2011 meeting.

Practice Committee Report:

Ms. Stone Murai reported that the Practice Committee met this morning prior the Board meeting at which time the following topics were discussed:

APRN-Rxs Prescribing Controlled Substances – Status Report

The EO provided a verbal report on the status of APRN-Rxs Prescribing Controlled Substances, the application form for APRN-Rx for Controlled Substances, requirements that include registration with the Department of Public Safety, Narcotics Enforcement Division and the U.S. Department of Justice, Drug Enforcement Administration.

Amendments to HAR Chapter 89, Based on Act 110, SLH 2011

Ms. Stone Murai reported that the Committee reviewed proposed amendments to HAR Title 16, Chapter 89 to align the administrative rules with the current law, more specifically Act 110, SLH 2011 and past Acts and also discussed the possibility of "collapsing" the APRN-Rx license into the APRN license. She explained that by "collapsing" the separate APRN-Rx license and making the prescriptive authority a privilege that the APRN will still have to apply for but no separate APRN-Rx license will be issued that will also eliminate the license and other fees normally assessed for a separate license. She reported that once the Committee accepts a final draft, it will be presented to the Board for consideration/discussion.

Joint Formulary Advisory Committee & Exclusionary Formulary for APRN-Rxs

The EO reported that the Joint Formulary Advisory Committee will be meeting on August 24, 2011 to discuss the Exclusionary Formulary for APRN-Rxs.

Ms. Stone Murai announced that the Committee will be meeting before the September 1, 2011 Board meeting at 8:30 a.m.

Upon a motion by Ms. Stone Murai, seconded by the Vice Chair, it was voted on and unanimously carried to accept the report of the Practice Committee's August 11, 2011 meeting.

Old Business:

HAR Chapter 89 – Proposed Amendments to Collapse APRN-Rx License into APRN License (Recognition)

As previously reported, the EO will be working on amendments to HAR Chapter 89 to collapse the APRN-Rx license and making prescriptive authority a privilege instead of a separate license.

Correspondence:

Public Health Nurses, Evelyn Boiser and Laurie Makaneole

The Board discussed and reviewed an additional question from Ms. Boiser and an email from Ms. Makaneole regarding the Board's previous response to Ms. Boiser. Ms. Boiser asked "How is it legal for the School Health Aides to administer medications without a nursing license or anyone delegating this action?" Ms. Boiser referred to HRS 302A-853, which she indicates allows unlicensed public aides to administer medications with the approval of the Department of Health.

The Board reviewed the additional information submitted by Ms. Boiser regarding a flow chart or "Algorithm when Request for Medication to be given in School", a Department of Education form, "Request to Store and Administer Emergency Rescue Medications or Daily, Routine, Scheduled Medications" that includes a "Notice to Parents/Legal Guardians and Physicians" on "Information Regarding Request to Store and Administer Medication in School" and a Public Health Nursing Consultation Report.

The Board discussed notifying the Department of Health ("DOH") and Department of Education ("DOE") of the concerns shared by Ms. Boiser.

Executive Session: At 10:46 a.m., upon a motion by Ms. Stone Murai, seconded by the Vice Chair, it was voted on and unanimously carried to move into Executive Session in accordance with HRS, 92-5(a) (4), To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities;".

At 12:31 p.m., upon a motion by the Vice Chair, seconded by Ms. Cohen, it was voted on and unanimously carried to move out of Executive Session.

The Chair moved out of order of the agenda to discuss item #12, Adjudicatory Matters.

Adjudicatory Matters: The Chair called for a recess from the meeting at 12:31 p.m. to discuss and deliberate on the following adjudicatory matter pursuant to Chapter 91, HRS.

In the Matter of the License to Practice Nursing of *Dorothy Wilson, RNS 2009-31-L*; Hearings Officer's Findings of Fact, Conclusions of Law and Recommended Order; Board's Final Order

Upon a motion by Ms. Stone Murai, seconded by the Vice Chair, it was voted on and unanimously carried to approve the above Board's Final Order.

Following the Board's review, deliberation, and decisions in these matters, pursuant to Chapter 92, HRS, the Chair announced that the Board would reconvene to its scheduled open meeting at 12:34 p.m.

The Chair moved back to the order of the agenda to discuss item #10 Correspondence.

The DAG left the meeting at 12:34 p.m.

After some discussion, it was the consensus of the Board that although they share Ms. Boiser and Ms. Makaneole's concerns for the safety of the student, it does not appear that the Board has jurisdiction in this matter since the Board does not "regulate" or have jurisdiction over the administration of medications by "unlicensed personnel" in the school setting. The Board also determined that not only nurses can administer medications that are not delegated by a healthcare professional such as a Public Health Nurse but, in this case, by the Principal of the school and that the Board supports their concerns and the Board is willing to respond to any questions from the DOE or DOH regarding the nursing scope of practice.

Nursing Jobs in Hawaii, Nancy Warner

The Board reviewed the following email from Ms. Warner:

"I really think the board of nursing should have a look at the market in Hawaii. [Their] There are little to no jobs available except to EXPERIENCED ICU, CCU, NICU, ER --- nurses. The new graduates are being treated like slave labor and the older nurses are completely shut out of the job market. A large majority of new grads are working as CNA's. It won't be long before they give up on nursing all together. Hawaii is going to end up with substandard practices due to fear of loosing their jobs. The word on forms for nurses is it takes 6 months to a year to get a job here. I am experiencing this now even though I have had 29 years of active nursing in many different areas of the country. The survey sent out with the renewals didn't touch on this issue. Excuse my ranting but I think unless the board gets a grip on this situation Hawaii will end up with a substandard nursing environment that no one will want to work in. Take a look at the studies from New York and California from 20 years ago and you have Hawaii."

After some discussion, the Board decided to refer Ms. Warner's email to the Center for Nursing because one aspect of study for the Center for Nursing is to study new graduate registered nurses turnover and best practices in retention of nurses.

Nurse Practitioner Scope of Practice Question, Michael J. Palazzo

The Board reviewed and discussed the following email inquiry from Mr. Palazzo:

"Questions for the Board of Nursing:

"I need clarification on whether or not I can treat children and adolescents within my Scope of Practice if I am certified by the ANCC in Adult Psych.

This month I resigned from Public Safety and now work for Kalihi Palama (KP) four days a week from 8am – 4pm:

1. Wednesday at KP Health Care for the Homeless at Sumner Street IHS men's shelter clinic
2. Thursday at KP Health Care for the Homeless at Kaaahi Street IHS women's shelter clinic
3. Friday at KP Behavioral Health at the 952 North King Street clinic
4. Saturday at KP Behavioral Health at the 952 North King Street clinic

I also work Tuesday from 8am – 4pm at Care Hawaii Inc. as an Independent Practitioner.

I edited the below meeting minutes in an attempt to explain to the staff at Kalihi Palama what I can and cannot do within my Scope of Practice. I informed them that I would consult the Board of Nursing regarding the treatment of children and adolescents and the use of narcotics.

1. Would I need to be Board Certified and Child and Adolescent Psychiatry to treat this population if I am Board Certified in Adult Psychiatry? Yes, you will need to be nationally certified as a CNS in Child & Adolescent Psychiatric & Adult Mental Health or Child & Adolescent Psychiatric & Mental Health.

2. When will APRNRXs in Hawaii be able to apply for a DEA#? We have been in contact with the U.S. Department of Justice, Drug Enforcement Administration to inform them of the Hawaii laws and rules that provide Hawaii APRN-Rx's to prescribe controlled substances. We have been advised that they are reviewing the information.
3. Currently at Kalihi Palama I collaborate with the Medical Director for medications requiring a DEA number. He is not a psychiatrist. Will the new DEA program require that I find a psychiatrist to collaborate with at Kalihi Palama or can I continue to collaborate with the Medical Director if psychiatrists at Kalihi Palama are unable or uncomfortable about this process? No, the working relationship or collaborative agreement was repealed this past legislative session (Act 110, SLH 2011).

Treating Adults Verses Children and Adolescents

The Board of Medicine allows Medical Doctors (MDs) who are Board Certified in Adult Psychiatry to treat child and adolescent psychiatric clients. It is unclear if the Board of Nursing would allow Michael to treat children and adolescents without being Board Certified in this specialty.

Michael is licensed by the State of Hawaii, Board of Nursing to prescribe psychotropic medications. The Board requires that the following 3 licenses remain active: Registered Nurse (RN), Advanced Practice Registered Nurse (APRN) and Advanced Practice Registered Nurse with Prescriptive Privileges (APRNRX). The Board of Nursing further requires a current Board Certification by the American Nurses Credentialing Center in Washington DC for the APRN and APRNRX licensing. This requires a Masters Degree in Nursing (MSN), 1,500 clinical hours and completion of the National APRN Certification Examination for Clinical Nurse Specialists or Nurse Practitioners. Michael completed the MSN, clinical hours, and passed the Board Certification Examination in Adult Psychiatry. There is a separate MSN specialization and clinical hours required prior to taking the Board Certification Examination in Child and Adolescent Psychiatry. Most nursing schools including UH and HPU do not offer the child and adolescent psychiatry MSN specialization. Michael could complete the clinical hours and specialty requirements as an online distance learner at Vanderbilt University. He could complete his clinical hours under Professor Marry Jane Amundson PhD, APRNRX who is working with children and adolescents at TIFFE (The Institute For Family Enrichment) in Honolulu. This process would involve 30 credits over 12 months. He will check with the Board of Nursing to find out if this is required or just suggested.

Michael also has a doctorate in nursing, but this is not required to prescribe medications as an APRNRX. The PhD in nursing trains nurses to write grants, conduct research and teach.

Prescribing Non-Narcotic Psychotropic Medications Verses Narcotics

Nurses with Prescriptive Privilege can prescribe all FDA approved psychotropic medications e.g. Lithium for bipolar disorder, Celexa for depression and Risperdal for schizophrenia. Advanced Practice Nurses in Hawaii have never been authorized to prescribe narcotics like Ritalin or Valium in Hawaii. A Drug Enforcement Agency (DEA) license is required to prescribe narcotics. Last year the Legislature passed and this year the Governor signed into law a process that will allow nurses to apply for Drug Enforcement Agency (DEA) licenses. The Board of Nursing is expected to start the DEA

Licensing application process this fall. At Care Hawaii Inc. the Medical Director Dr. Giannasio and at Kalihi Palama the Medical Director Dr. Lowry is consulted if an APRNRX has a client requiring a narcotic. In these cases the Medical Director's DEA numbers are used. When the APRN prescribes non-narcotic medications they use their own license numbers. Up until last year the nurse would also need to provide the name of a collaborating psychiatrist to prescribe non-narcotic medications, but the law was changed last year and now APRNRXs can practice independently without a collaborating psychiatrist. When a medication is called into the pharmacy the APRNRX's Call Number is used. Call Numbers are issued by the State of Hawaii, Department of Public Safety. When APRNRXs in Hawaii receive DEA Numbers they will be able to use their own Numbers, but for the first 2-years they will also have to give the name of a collaborating psychiatrist."

The Board determined that an individual may be qualified for APRN licensure (recognition) based on their national certification for a specific specialty and that nothing prohibits the individual from obtaining additional specialties via national certification recognized by the Board.

Therefore, the Board responded to Mr. Palazzo's questions as follows:

1. Would I need to be Board Certified and Child and Adolescent Psychiatry to treat this population if I am Board Certified in Adult Psychiatry?

Yes, you will need to be nationally certified as a CNS in Child & Adolescent Psychiatric & Adult Mental Health or Child & Adolescent Psychiatric & Mental Health.

2. When will APRNRXs in Hawaii be able to apply for a DEA#?

We have been in contact with the U.S. Department of Justice, Drug Enforcement Administration to inform them of the Hawaii laws and rules that provide Hawaii APRN-Rx's to prescribe controlled substances. We have been advised that they are reviewing the information.

3. Currently at Kalihi Palama I collaborate with the Medical Director for medications requiring a DEA number. He is not a psychiatrist. Will the new DEA program require that I find a psychiatrist to collaborate with at Kalihi Palama or can I continue to collaborate with the Medical Director if psychiatrists at Kalihi Palama are unable or uncomfortable about this process?

No, the working relationship or collaborative agreement was repealed this past legislative session (Act 110, SLH 2011).

Request for Recognition by the Wound, Ostomy Continence Nursing Certification Board as a Nurse Practitioner Specialty

The Board reviewed an email request from Anne Jimbo requesting the Board recognize Wound, Ostomy and Continence as a subspecialty for APRN recognition.

After some discussion, the Board determined that based solely on the information provided they are unable to recognize Wound, Ostomy and Continence as a subspecialty for APRN recognition at this time as there was insufficient information for their consideration.

National League for Nursing Accrediting Commission, Inc. (NLNAC) - Hawaii Community College

The Board reviewed a letter from the NLNAC granting Hawaii Community College's Associate Nursing Program continuing accreditation.

Question on Nurse Licensure Compact, Jillian Yasutake, Department of Labor and Industrial Relations

The Board reviewed Ms. Jillian Yasutake's email requesting history or information as to why Hawaii has not established under the Nurse Licensure Compact ("NLC")? Also, that NLC is tied to federal loan reimbursement funds.....is this true and in what way?

After some discussion although they agree that adopting the NLC would allow out-of-state nurses to come to Hawaii and Hawaii nurses to practice in other compact states more easily, however, there are other factors to consider that may require more studies, including but not limited to determining the fiscal impact on the Board, Hawaii nursing programs and their graduates, State facilities that utilize nurses, etc. and the impact on the nursing workforce and how to bring Hawaii's current nursing practice conducive to the NLC.

As for ties to federal loan reimbursement, the Board recommends that Ms. Yasutake contact the National Council of State Boards of Nursing for more information.
