The Vice Chair recommended the following amendment:

Page 11, first paragraph, second line, delete the word "has" preceding "jurisdiction".

The Chair called for a motion in regards to the executive session minutes of the September 1, 2011 meeting.

The DAG recommended the following amendments:

Page 1, second paragraph, delete the apostrophe in the word "applicant's".

Page 1, last paragraph, it should read as follows, "The Vice Chair informed Ms. Honda that the Board requested her appearance to discuss her convictions/arrests. She asked Ms. Honda how her license will not be impacted by her arrests."

Page 2, first paragraph, delete "in" and replace with "if", and delete the comma after the "incident".

Page 2, third paragraph, insert quotes as follows: "her one time deal."

Page 2, under Brian Lohr, fourth paragraph, insert quotes as follows: "by not making poor choices, thinking things through, making better plans when going out, and have plans in place ahead of time."

Page 3, delete the third paragraph.

Page 4, under Micki McCollister, second to the last paragraph, delete "license" and replace with "arrest".

Executive Officers Report: **Regulated Industries Complaints Office ("RICO") Nursing Advisory Committee and Addendum**

The Board reviewed a list of possible advisory committee members. The EO informed members if they know any other individuals who may be interested in serving on the advisory committee to provide her with their contact information so that she can forward to RICO.

Upon a motion by the Vice Chair, seconded by Ms. Stone Murai, it was voted on and unanimously carried to approve the list of the Nursing Advisory Committee and Addendum language, as submitted by RICO.

Education Committee Report: Ms. Cohen reported that at the September 1, 2011 meeting, the committee discussed the following:

Annual Reports

UH Hilo

The Committee deferred UH Hilo's annual report and requests that UH Hilo resubmit their annual report utilizing the new annual report form.

Quarterly Reports

Kauai Community College

The quarterly report submitted for the Fall 2011 Faculty Clinical Assignments was deferred for more information.

Hawaii Pacific University

The quarterly report submitted for the period covering April - June 2011 was accepted.

Distance Learning

University of Texas at Tyler

The Committee addressed a request from the University of Texas at Tyler asking if one of their students, who will be moving to Hawaii, can continue in their distance learning program and do her clinicals with a preceptor in Hawaii.

The Committee determined that the preceptor in Hawaii would have to be a licensed Hawaii nurse.

Felician College

The Committee addressed an inquiry from Felician College asking if there are any statutory or regulatory requirements for out-of-state distance programs and whether or not the utilization of health care facilities such as hospitals or private practice by advanced nursing practice students residing in our State, requires additional approval.

The Committee determined that nurses seeking recognition as an advanced practice registered nurse must complete an accredited graduate-level education program leading to a master's degree as a certified registered nurse anesthetist, a nurse midwife, a clinical nurse specialist or a nurse practitioner, pursuant to Hawaii Revised Statutes §457-8.5 and that the preceptor for the clinical portion of the curriculum, if conducted in Hawaii, would have to be by a nurse who is licensed in this State. Also, nursing programs located in this State, require Board approval.

Indiana State University

The Committee addressed an inquiry from the Indiana State University asking if their online nursing course for their RN-BS and post-licensure nursing education must be approved by the Board.

The Committee determined that nurses who apply to sit for the NCLEX-RN shall meet the education requirement pursuant to Hawaii Revised Statutes ("HRS") §457-7, by graduating from a registered nursing program at an education institution in the United States or any territory or possession under the jurisdiction of the United State or graduated with a bachelor's degree and satisfactorily completed the pre-licensure portion of a master's entry program in nursing at an accredited school of nursing in the United States or any territory or possession under the jurisdiction of the United States that is recognized by the board or other state boards of nursing. And that a registered nurse seeking recognition as an advanced practice registered nurse must complete an accredited graduate-level education program leading to a master's degree as a certified registered nurse anesthetist, a nurse midwife, a clinical nurse specialist or a nurse practitioner, pursuant to HRS §457-8.5.
