Call to Order: The Chair called the meeting to order at 9:30 a.m. at which time quorum was established.

Additions/Additional Distribution: The Chair said the following was distributed to the Board members as additional distribution:

9. Old Business
 - a. Amendments to HAR Title 16, Chapter 89 – Status Report – DAG's Comments

Approval of the Minutes: The Chair called for a motion in regards to the regular minutes of the March 1, 2012 meeting.

The Vice Chair made the following recommendations:

- On page 3, under "HB 2023/SB 2182 – Relating to the Center for Nursing", the word "makes" in the first sentence should be amended to "make";
- On page 6, under "**Next Education Committee Meeting**", in the second paragraph, delete the last word in the sentence ending with "Chair"; and
- Throughout the minutes, when referring to the "Center for Nursing", capitalize "C" in "Center" and "N" in "Nursing".

The DAG made the following recommendations:

- On page 8, under "Adjudicatory Matters", the second paragraph should read as follows:
"In the Matter of the License to Practice Nursing of Darren T. Ishii, RNS 2009-23-L; Hearings Officer's Findings of Fact, Conclusions of Law, and Recommended Order."
- On page 8, under "Adjudicatory Matters", the fourth paragraph should read as follows:
"The Board accepts the Hearing Officer's Findings of Fact and Conclusions of Law and to issue its own Board's Proposed Final Order."

The Chair asked for any corrections to the executive session minutes.

There being no further amendments or discussion, upon a motion by Dr. Kula, seconded by Ms. Stone Murai, it was voted on and unanimously carried to approve the minutes of the March 1, 2012 meeting as amended and circulated.

Chair's Report:

Report on Attendance at NCSBN Mid-Year Meeting

The Chair reported on his attendance at the NCSBN Mid-Year meeting which he attended with Ms. Cohen.

The Chair stated that he attended the Leadership training and based on the discussion with other boards of nursing, Hawaii appears to be "ahead of the game" when it comes to its practice act and "functional" when it comes to how the Board conducts its business. For example, other boards were surprised that Hawaii meets every month, as compared to other boards which may meet only four times a year, but for several days. Some boards conduct its own investigation, whereas, the Regulated Industries Complaints Office is the statutorily-mandated agency that investigates and prosecutes disciplinary cases for the Hawaii Board. The Chair also stated that there will be changes to the NCSBN Model Act.

Ms. Cohen reported that she attended the education session where she learned that in Utah, the board of nursing was unaware of legislation that does not require board

approval for a nursing program, if the nursing program located in Utah, was nationally accredited. Ms. Cohen stated that this took away the board's authority over nursing programs located in that state. She also reported that one of the topics of discussion was about the LPN scope of practice and expanded delegation by LPNs to nurse assistants in a long term care facilities although the LPN education may not support the expansion of the LPN's role to delegate and that only 6% of the LPN programs are accredited. She also reported that there was a presentation by different attorneys.

Vice Chair's Report:

The Vice Chair stated that she did not have anything to report.

Executive Officer's Report:

2012 Legislature Report

The EO reported on the following legislative bills:

SB 2103 – Relating to Health

This bill, which amends the definitions of "the practice of nursing as a licensed practical nurse" and "the practice of nursing as a registered nurse" to require licensed practical nurses and registered nurses to carry out the orders of a physician that are delivered through a physician assistant acting as an agent of the supervising physician, was heard by the House Consumer Protection and Commerce Committee on Monday, April 2, 2012, and the Chair of the committee recommended that the bill be passed out with amendments recommended by the UH @ Manoa, School of Nursing and Dental Hygiene. The Board members were provided a copy of UH @ Manoa's testimony and asked if they had any comments.

It was the consensus of the Board that the proposed amendments made to UH @ Manoa to section 457-8.5(a)(4) would allow an applicant who obtained a master's or doctoral degree in nursing to qualify for APRN recognition.

HB 2023/SB 2182 – Relating to the Center for Nursing

These bills make permanent the assessment and deposit of Center for Nursing fees into the Compliance Resolution Fund and distribution of those funds to the credit of the Center for Nursing special fund.

The EO stated that both bills crossed over to the House and Senate respectively. HB 2023 was heard by the Senate CPC and WAM Committees and passed out unamended. SB 2182 was heard by the House Health and Higher Education Committee and referred to the Finance Committee which has not scheduled a hearing to date.

SCR 53 – Requesting Collaboration Among Various Agencies to Identify and Remove Barriers Relating to Workforce Data Sharing and Nursing Practice in the State

The resolution was heard by the Senate CPN Committee who passed it out with amendments (amend the deadline for the draft of the report to the Legislative Reference Bureau to November 1, 2012) and referred to WAM which has not yet scheduled a hearing.

Conference/Meetings/Seminars

American Academy of Nurse Practitioners Annual Region 9 Invitational Leadership Meeting,
April 21, 2012, San Diego, California

Information regarding this meeting was distributed to the Board members for their information.

Ms. Stone Murai stated that she would let the AANP know that no member from the Hawaii State Board of Nursing would be able to attend.

The Board members were also verbally informed about the upcoming 2012 NCLEX conference, September 24, 2012 to be held in Boston, Massachusetts and NCSBN's 2012 Scientific Symposium, September 11, 2012, to be held in Arlington, Virginia and that if anyone was interested to let the EO know.

Report on Continuing Education Joint Advisory Committee

Ms. Tiwanak addressed the Board to provide an update on the Continuing Education Joint Advisory Committee ("CEJAC"). She reported that the committee members have been doing community presentations and most of the nurses have been supportive for a continued competency program focusing on life-long learning instead of just requiring continuing education. She also stated that the committee is working on the cost analysis that includes employer/employee impact and impact on the agencies and that it will probably be the recommendation of the committee that continued competency be recommended for nurse license renewal.

Dr. Kula asked if additional funding is needed to implement the program and if so, whether the Legislature would be able to help fund the program or whether this would require additional license fees.

Ms. Tiwanak responded that perhaps it would be a combination of both.

Dr. Kula asked if the committee has been able to identify the agency to "run" the program and if it is the Center for Nursing, would they have to "leave" UH?

Ms. Tiwanak responded that the Center for Nursing was considered more as a clearing house for the continuing education, however, normally it is the Board's laws and rules that would have to be amended to require the continued competency as part of the renewal requirement, therefore, oversight of the program may fall under the Board.

Ms. Cohen asked when the committee did its comparison with a similar program, if they also compared the Board being under an umbrella agency versus an autonomous Board?

Ms. Tiwanak responded that of the states that require continued competency, New Hampshire appeared to be more comparable to Hawaii.

There being no further discussion, Ms. Tiwanak announced that she will be retiring in June of this year and that the new Director is Deborah Gardner. She also thanked the Board for their support.

The Board thanked Ms. Tiwanak for her dedication and work as the Center for Nursing's Director these past years.

Practice Committee: **Report from April 5, 2012 Meeting**

Ms. Stone Murai reported on the following topics discussed at the meeting this morning:

Proposed Amendments to HAR Chapter 89

The Committee reviewed the draft of the proposed amendments to Chapter 89 that included the DAG's comments and recommended the following to be discussed at the Board meeting:

1. §16-89-64, consideration of amending the number of years from three to six that an applicant, whose license has been revoked by the Board, can apply for relicensure.

After some discussion, upon a motion by Ms. Stone Murai, seconded by Dr. Kula, it was voted on and unanimously carried to delete §16-89-64 because an individual whose license has been revoked must reapply as a new applicant, which makes this section unnecessary.

2. §16-89-81, clarify if reference to schedules I – V of Chapter 329, should be included or deleted in section (d).

It was the consensus of the Board that reference to schedules I – V of Chapter 329 should have been deleted previously as it is already bracketed.

3. Subchapter 15, consider amending the title of the subchapter to "Delegation of Nursing Care Special Tasks to Unlicensed Assistive Personnel".

After some discussion, upon a motion by the Vice Chair, seconded by Mr. Hoban, it was voted on and unanimously carried to amend the title of subchapter 15 to read as follows, "Delegation of Nursing Care Tasks to Unlicensed Assistive Personnel".

4. Exhibit A, include the word "not" in the second paragraph after the word "shall".

Upon a motion by Ms. Cohen, seconded by Dr. Kula, it was voted on and unanimously carried to accept the amendment to Exhibit A as stated above.

Ms. Stone Murai also noted that the DAG also made some grammatical and format recommendations and thanked the DAG for a thorough review and her recommendations.

The EO reported that the changes will be made and the next step is for the proposed amendments to be reviewed and considered by the Small Business Regulatory Review Board.

APRN Certifications

After some discussion, the Committee decided to have Ms. Stone Murai and the EO work on the applications for APRN Recognition and APRN-Rx and report back to the Committee.

Developmental Disabilities Nurses Association

The Committee asked the EO to see if she could obtain additional copies of the Developmental Disabilities Nurses Association's Position Paper on Medication Management for Individuals with Intellectual and Developmental Disabilities or to see if this was available on the internet and if it could be forwarded to the Board members.

Education Committee: **Request from Eluned Mun, RN, MS – Additional Information**

After some discussion, upon a motion by the Vice Chair, seconded by Dr. Kula, it was voted on and unanimously carried to refer Ms. Mun's request to the Education Committee for a recommendation.

Ms. Cohen also reported that the Education Committee will be meeting after today's Board meeting.

Old Business: **Amendments to HAR Title 16, Chapter 89 – Status Report**

The Chair stated that this was previously discussed under the Practice Committee report.

Participation in NURSYS

The EO reported that she is trying to get the PDF files of the redacted Board's Final Order so that it can be attached to the disciplinary action report filed with NURSYS.

Ms. Stone Murai asked the DAG if she received the contracts from NURSYS.

The DAG stated that she did.
