Call to Order: The Chair called the meeting to order at 9:48 a.m. at which time quorum was established.

Additions/Additional Distribution: None.

Approval of the Minutes: The Chair called for a motion in regards to the regular minutes of the April 5, 2012 meeting.

Ms. Stone Murai made the following recommendation:

- On page 4, under "Executive Officer's Report", "**Report on Continuing Education Joint Advisory Committee**, first paragraph, line 3, change "for" to "of".

The Chair asked for any corrections to the executive session minutes.

There being no further amendments or discussion, upon a motion by the Vice Chair, seconded by Dr. Fleming, it was voted on and unanimously carried to approve the minutes of the April 5, 2012 meeting as amended and circulated.

Chair's Report: None.

Vice Chair's Report: The Vice Chair stated that as a member of the Board, she is on the NCLEX Item Review Subcommittee. However, since her term as a Board member will expire next year, she will no longer be on the subcommittee and suggested that if any Board member is interested in serving on the subcommittee, they should apply.

Dr. Fleming said she was interested.

Executive Officer's Report: **2012 Legislature Report**

The EO reported on the following legislative bills:

HB 2023 – Relating to the Center for Nursing

This bill was signed into law by Governor Abercrombie on April 23, 2012. This bill makes permanent the assessment and deposit of Center for Nursing fees into the Compliance Resolution Fund and distribution of those funds to the credit of the Center for Nursing special fund.

SB 2103 – Relating to Health

This bill, which amends the definitions of "the practice of nursing as a licensed practical nurse" and "the practice of nursing as a registered nurse" to require licensed practical nurses and registered nurses to carry out the orders of a physician that are delivered through a physician assistant acting as an agent of the supervising physician, was heard by a Committee on Conference with members from both the House and Senate. As a result, the Committee on Conference amended the bill by reverting it back to the S.D. 2 version by not amending the formal education requirement for recognition as an advanced practice registered nurse and changing the effective date to upon approval. The Committee on Conference also inserted a repeal date of July 1, 2017.

The EO stated that when she last checked, the measure had passed final reading on May 2, 2012 but was not yet enrolled to the Governor.

SCR 53 – Requesting Collaboration Among Various Agencies to Identify and Remove Barriers Relating to Workforce Data Sharing and Nursing Practice in the State

The EO reported that the concurrent resolution crossed over to the House but was not scheduled for hearing.

The EO also informed the Board of 2 bills relating to professional and vocational licensing that allows licensing boards to allow nonresident military spouse applicants to demonstrate competency in lieu of work experience requirements and establish procedures to expedite the issuance of licenses, certifications, or permits to nonresident military spouses under certain conditions and to consider military education, training, or service toward the qualifications for a license and to adopt rules accordingly.

Report on Continuing Education Joint Advisory Committee

The EO reported that the next scheduled meeting for the Committee is scheduled for June 8, 2012. Ms. Cohen stated that she would be calling into the meeting.

Request from the Board of Pharmacy

The EO explained that the Board of Pharmacy has requested a meeting with representatives of the Board to discuss and clarify the APRN's scope of practice and specialties so that pharmacists may have a better understanding of the APRN's prescriptive authority.

The Chair recommended himself, Ms. Stone Murai and Ms. Cohen to represent the Board.

The EO stated that she will discuss with the Board of Pharmacy and try to schedule the joint meeting.

Addition to the Regulated Industries Complaints Office Nursing Advisory Committee

After some discussion, upon a motion by the Vice Chair, seconded by Ms. Cohen, it was voted on and unanimously carried to approve the addition to the Nursing Advisory Committee.

Practice Committee: No report.

Education Committee: Ms. Cohen reported on the following:

April 5, 2012 Meeting

- Annual Report Form – The Committee is still reviewing and revising the Annual Report Form;
- Establishing an Annual Pass Rate – It was the consensus of the Committee to recommend that the Board require Hawaii nursing programs to have annual pass rates that are at least 90% of the national average pass rate. The NCSBN NCLEX Examinations determines the national average pass rate for first-time, US-educated exam candidates for the past year. Using this formula for 2011, the acceptable annual pass rate was 79.11% for Hawaii registered nurse programs, and 76.35% for Hawaii licensed practical nurse programs;
- Review of G-4 Reports for Hawaii Nursing Programs – Based on the above mentioned pass rates, the Committee reviewed the annual pass rates for 2011 for Hawaii nursing programs and determined that the following programs fell below the recommended annual pass rate for 2011: RN program – Hawaii Community College, Hawaii Pacific University and University of Phoenix, LPN program – Hawaii Community College;
- Proposed Amendments to HAR Chapter 89 – Deferred;
- Definition of “continuing education”, “contact hours” and “AMA Category 2 CEs” – Deferred;
- Request from Walden University's MSN Programs for Family NP and Adult/Gerontology NP – The Committee reviewed questions submitted by Walden University and recommends the following response:

1. The Board currently recognizes the FNP and Adult NP or Gerontological NP but not a combination AGNP. However, this may be an issue to be addressed by the Board's Practice Committee;
 2. There are no laws or rules requiring NP students to complete practicum hours in this State if the applicant is not enrolled in a Board approved nursing program; and
 3. Currently, the laws and rules pertaining to nursing programs do not list specifications for online nurse practitioner programs.
- South Dakota University RN and LPN Refresher Course – The Committee reviewed the information received from South Dakota University's RN and LPN Refresher course and recommends the Board accept these courses to satisfy the didactic component of the refresher or continuing education course requirement for an individual nurse licensee or applicant who has not actively practiced nursing in this State or any other state in the U.S. or territory or possession under the jurisdiction of the U.S for more than five years.;
 - Eluned Mun – The Committee requested that Ms. Mun submit her transcripts that indicates pharmacology and pathophysiology graduate level courses;
 - Foreign Educated Applicants – The Committee reviewed the following applications, including the CGFNS reports, where applicable, and any additional information submitted and recommends the following:
 1. Arulappen, Anne P. – Accept CGFNS report and approve to sit for NCLEX
 2. Kalinovik, Tatsiana V. – Accept CGFNS report and approve to sit for NCLEX
 3. Kirilyuk, Galina – Accept CGFNS report and approve to sit for NCLEX
 4. Plotnikov, Nadezhda V. – Accept CGFNS report and approve to sit for NCLEX
 5. Thibodeau, Karen – Accept CGFNS report and approve to sit for NCLEX
 6. Vandiver, Nataliya – Accept CGFNS report and approve to sit for NCLEX
 7. Kritovich, Yelena – Accept CGFNS report and approve to sit for NCLEX
 8. Lee, Ramona – Uphold previous Board's decision of December 1, 2011.

May 3, 2012 Meeting

- Annual Report Form – The Committee continued their review and discussion of the form;
- Review of Annual Pass Rate for Hawaii Nursing Programs – The Committee recommends the following nursing programs be informed that their 2011 annual pass rate fell below 90% of the national annual pass rate and to submit a quarterly report for the period covering January – March, 2012. The Committee also continued their discussion on the acceptable annual pass rate for Hawaii nursing programs and members will be researching how other states determine the pass rate and report back to the Committee for further discussion;
- Proposed Amendments to HAR Chapter 89 – Deferred;
- Definition of "continuing education", "contact hours" and "AMA Category 2 CEs" – Deferred;
- Request from Eluned Mun – The Committee reviewed Ms. Mun's Master's in Pharmacology transcripts that indicate pharmacology and pathophysiology graduate level courses and recommends that the Board accept Ms. Mun's pharmacology and pathophysiology courses in addition to the completion of an accredited graduate-level nursing program requirement for prescriptive authority.

- Question Regarding University of Hawaii@Manoa MEPN Program – The Committee reviewed an email from Tracie Asayama regarding proposed changes to the doctoral degree in Nursing for 2015. Dr. Mukai stated that the requirement for a DNP to qualify for certification in 2015 is under the jurisdiction of the certifying body and Ms. Asayama needs to clarify qualifications with these certifying organizations. Also, the DNP and MEPN are academic programs and information about them should come from the academic institution, not the BON. The BON reiterates that APRN recognition requires that candidates meet qualifications as described in HRS 457-8.5.
- Requirements for Nurse Internships in Hawaii – A student enrolled in a nationally accredited nursing school or program recognized by the Board, may perform their internship in Hawaii provided that the preceptor is a Hawaii licensed nurse.

Upon a motion by Ms. Cohen, seconded by the Vice Chair, it was voted on and unanimously carried to accept the report and recommendations of the Education Committee.

Old Business:

Amendments to HAR Title 16, Chapter 89 – Status Report

The EO stated that she is working on the justification.
