- Call to Order: The Chair called the meeting to order at 9:34 a.m. at which time quorum was established.

The Chair excused Ms. Cohen and Dr. Kula.
- Introduction of Jo Ann Uchida Takeuchi, Deputy Director of the Department of Commerce and Consumer Affairs
- This matter was deferred to the September 6, 2012 board meeting.
- Additions/Additional Distribution: The Chair moved to amend the agenda, item 10.c.3) should read "APRN Education". It was seconded by the Vice Chair, voted on and unanimously carried.
- Approval of the Minutes: The Chair called for a motion in regards to the minutes of the July 12, 2012 meeting.

There being no amendments, upon a motion by the Vice Chair, seconded by Ms. Fleming, it was voted on and unanimously carried to approve both the meeting minutes and executive session minutes of the July 12, 2012 meeting as circulated.

Chair's Report: **Drug Testing for Licensure – Discussion Only**

The Chair indicated that Beth Radtke from NCSBN discussed the Uniform Code of Licensure and the requirement for drug testing of license applicants.

Ms. Elvenia asked who would pay for the background check and would it be for initial as well as the renewal of the license?

The Vice Chair stated that each facility will do a drug test for individuals.

The Chair stated that the drug test results of an individual from one facility may not be accepted by another facility.

Vice Chair's Report: None.

Executive Officer's Report: **Report on July 12, 2012 Joint Meeting with the Board of Pharmacy Regarding APRN-Rx for Controlled Substances**

The EO reported that the Chair, Ms. Cohen, and Ms. Stone Murai met with representatives of the Board of Pharmacy consisting of the Board of Pharmacy's Chair, Mark Brown, Vice Chair, Patrick Adams and public member Lydia Kumasaka, APRN.

She reported that the Board of Pharmacy representatives wanted clarification on the APRN-Rx scope of practice, specifically how the Board interprets the laws, open formulary, and specialties so that pharmacies may be more cooperative in filling prescriptions written by APRN-Rx.

After some discussion, the joint committee decided on a guidance document to be disseminated to both the pharmacies and APRN-Rxs that includes information on the current practice (law) for APRN-Rxs, explanation of the specialties, instructions on how to verify an individual APRN-Rx's specialty and prescriptive authority on the PVL web page, what APRN-Rx's need in order to prescribe controlled substances and how pharmacists may call an APRN-Rx to verify a prescription.

The EO reported that she has started the guidance document and hopes to submit a draft to the joint committee members for their feedback/recommendations by the end of the month.

Practice Committee: **Report on August 2, 2012 Meeting**

Co-Chair Stone Murai reported on the following topics discussed at the meeting:

APRN Certifications

After some discussion, the Committee decided to have Co-Chair Stone Murai work with the EO on updating the APRN application.

Wound Treatment Training, Letter from Ed Lataro

The Committee reviewed a letter from Mr. Lataro in which he expressed his concerns with the treatment of his mother in several nursing homes and how "nurses" would not properly refer his mother to a physician for debridement, but would only change her bandages.

After some discussion, the Committee directed the EO to respond to Mr. Lataro, acknowledging receipt of his recommendations and that they will be taking it under advisement. The Committee also recommended that since Mr. Lataro referred to nursing homes, assuming the nursing homes are located in this State, to also refer him to the Department of Health and the Department of Human Services.

RN's Interpreting the ECG to Confirm Placement of the PICC, Inquiry from Isabelle

The Committee reviewed a faxed email inquiry regarding the above mentioned matter and it was their informal interpretation that based solely on the information provided, determined that the nursing practice does not specifically address this task, and to refer her to the definition of "The practice of a registered nurse" and that the scope of nursing practices established in the laws and rules shall serve as general guidelines and are not intended to address the appropriateness of the use of specific procedures in any particular work setting or to grant permission to implement specific procedures in any particular work setting.

Draft of VA Nursing Policy Document, NCSBN

The Committee reviewed the VHA Policies for Nursing Practice and did not have any major concerns or issues with the draft policies.
