Call to Order: The Chair called the meeting to order at 8:45 a.m. at which time quorum was established.
The Chair excused Mr. Hoban and Dr. Kula.

Introduction of Jo Ann Uchida Takeuchi, Deputy Director of the Department of Commerce and Consumer Affairs

Deputy Director Jo Ann Uchida Takeuchi recognized and acknowledged the members for volunteering their energy, time and efforts to the Board. She commended members on their important role in consumer protection.

She suggested that members contact the EO if they have any concerns and/or issues.

Deputy Director Uchida Takeuchi also spoke to members about the Board Chairpersons Orientation Meeting that was held on December 6, 2011 at which representatives from various agencies explained its function as it pertains to Boards and Commissions. Based upon the positive feedback after last year's orientation meeting, PVL will hold another board orientation on October 24, 2012 for all board members to attend. She encouraged members to attend.

The Vice Chair added that she attended the first orientation and found it to be very informative and encouraged members to attend.

Deputy Director Uchida Takeuchi thanked the member.

The Chair called for a motion in regards to the minutes of the August 2, 2012 meeting.

Ms. Stone Murai stated that on page 2, under "Practice Committee", it should read "APRN Certifications List Review".

There being no further amendments or discussion, upon a motion by Ms. Stone Murai, seconded by Ms. Fleming, it was voted on and unanimously carried to approve the minutes of the August 2, 2012 meeting as amended.

The Chair asked for a motion in regards to the August 2, 2012 executive session minutes.

Upon a motion by the Vice Chair, seconded by Ms. Cohen, it was voted on and unanimously carried to approve the executive session minutes of the August 2, 2012 meeting as circulated.

Vice Chair's Report:

Report on Attendance at NCSBN Annual Meeting

The Vice Chair reported it was very helpful to attend NCSBN annual meeting. She reported that should the Uniform Licensing Act be adopted by law it would impact the Hawaii Board immensely. She also mentioned that it was the recommendation of the delegate assembly to not amend the NCSBN model act in regards to the EO being an RN, discussion on the increase in the NCLEX-RN pass rate and concerns from the CGFNS regarding diploma mills.

Executive Officer's
Report:

Report on Attendance at NCSBN Annual Meeting

The EO reported that the annual meeting was quite impressive and it was the largest meeting she has attended.

She also reported that it was difficult to network with other boards due to large group sizes even during break out sessions.

2013 Board of Nursing Meeting Schedule

The Chair called for a motion to approve the 2013 Board Meeting Schedule.

Upon a motion by the Vice Chair, seconded by Ms. Stone Murai, it was voted on and unanimously carried to approve the 2013 meeting schedule.

Report from the Hawaii
State Center for Nursing:

Kathy Yokouchi and Dr. Deborah Gardner provided a proposed draft of a House Concurrent Resolution entitled "Requesting Collaboration Among Various State Agencies To Identify And Remove Barriers To Advanced Practice Registered Nursing Practice In The State" and a bill for an act entitled "Relating to Advanced Practice Registered Nurses", which proposed to amend HRS Chapters 321, 327C, 327E and 327G. Ms. Yokouchi stated she identified 33 major barriers among federal and state regulations and encouraged the Board and Center work together to amend the laws, including the possibility of introducing and supporting a "harmonizing bill".

The Chair asked why other departments support the reso and not the bill?

Ms. Yokouchi replied that perhaps its pressure and/or "Obamacare".

Ms. Stone Murai stated that another issue is under staffing.

Ms. Yokouchi also requested to be kept apprised of the Board's position/decision on the Board's comparison of the amendments to the NCSBN Model Act and Rule and the Board's current laws and rules.

The Vice Chair raised the issue about the MEPN program and that no nursing degree is issued.

Mr. Yokouchi encouraged the Board and the Center to develop a more mutual trust, an extension of each other and not a threat. She suggested that the Board work with the Center to determine what they can do to assist and strengthen efforts and also stated that the laws should be amended to reflect a "graduate degree", instead of a master's degree.

The EO clarified if the Center is considering the reso instead of the bill?

Ms. Yokouchi stated that the reso would allow the participation of various departments to work collaboratively in identifying "barriers" in their respective state statutes and administrative rules.

The Chair stated that he would like the Board members to take more time to review both the proposed bill and especially the reso and deferred this matter to the October meeting.

The EO thanked Ms. Yokouchi on her hard work in drafting proposed legislature relating to advanced practice registered nurses.

At this time the Chair wished to take the agenda out of order to address Chapter 91, HRS, Adjudicatory Matters.

Adjudicatory Matters:

The Chair called for a recess from the meeting at 9:32 a.m. to discuss and deliberate on the following adjudicatory matter(s) pursuant to Chapter 91, HRS

In the Matter of the License to Practice Nursing by Gail D. Benjamin, aka Gail B Kagawa; RNS 2009-25-L; Settlement Agreement After Filing of Petition for Disciplinary Action and Board's Final Order.

Upon a motion by the Vice Chair, seconded by Ms. Cohen, it was voted on and unanimously carried to accept/approve the Board's Final Order.

In the Matter of the License to Practice Nursing of Darren T Ishii, RNS 2009-23-L, Board's Proposed Final Order; Respondent Darren T. Ishii's Exceptions and Request for Oral Argument and Petitioner's Statement in Support and Exceptions to Board's Proposed Final order Filed on April 5, 2012

The Board heard oral arguments from Mr. Anthony Aguinaldo, Attorney for Mr. Ishii and Ms. Diane Corn, Staff Attorney for the Regulated Industries Complaints Office.

After consideration of the oral arguments of both counsels, upon a motion by the Vice Chair, seconded by Ms. Stone Murai, it was voted on and unanimously carried to amend the Board's Proposed Final Order as follows:

- Respondent's license be suspended for a period of five years from the date of the Final Order with three years stayed as long as respondent remains in compliance with the other conditions imposed;
- That within 60 days of the Board's Final Order, respondent must obtain Board approval for at least three (3) continuing education courses which are no less than six (6) hours in length in each of the following subject matter: 1) Professional conduct; 2) Ethics; and 3) Developmentally challenged patients' needs;
- Within one (1) year of the Board's Final Order, must complete the above mentioned continuing education courses and submit proof of completion to the Board; and
- The Board orders that respondent pay a fine in the amount of \$1,000.00 within ninety (90) days of the Board's Final Order.

Following the Board's review, deliberation, and decisions in these matters, pursuant to Chapter 92, HRS, the Chair announced that the Board would reconvene to its scheduled open meeting at 10:45 a.m.
