Executive Session: At 8:54 a.m., upon a motion by Ms. Chang, seconded by the Vice Chair, it was voted on and unanimously carried to move into executive session pursuant to §92-5(a)(1) and (4), HRS, "To consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in section 26-9 or both; and "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities;".

At 9:10 a.m., upon a motion by Ms. Shimabuku, seconded by Dr. Moon, it was voted on and unanimously carried to move out of executive session.

Renewal Application – Duane Rowe

The EO stated that Dr. Rowe submitted his 100-hour TPA certification course certificate to satisfy his CE requirement for license renewal. Dr. Rowe currently is not therapeutically certified.

The Chair noted that §16-92-38 (a), Hawaii Administrative Rules, states that licensees who are not therapeutically certified shall obtain thirty-two hours during the biennium in approved programs of continuing education for re-licensure.

After review and discussion, upon a motion by the Vice Chair, seconded by Ms. Shimabuku, it was voted on and unanimously carried to accept the 100-hour TPA certification course in lieu of the CE requirement of 32 hours of CE for his DPA license renewal for this biennium.

The Board also directed the EO to inform Dr. Rowe that for the upcoming biennium commencing January 1, 2012, he will be required to obtain thirty-two hours of approved CE hours for DPA renewal or thirty-six hours of approved TPA CE hours for renewal, whichever is applicable.

The Board reviewed CE certificates submitted by licensees for license renewal.
