Thomson Prometric: a. Examination Update

The Executive Officer indicated that she is in contact with Elizabeth Shamla of Prometric to update the exam and list of exam references. Business: a. Rules Committee

The Executive Officer indicated that the Rules Committee did not meet prior to the meeting as they are still awaiting HPCA's draft.

Ms. Tamanaha inquired with Mr. Lyons on the status of the HPCA's draft to the standards of a TIR. Mr. Lyons indicated that the Industry Standards Improvement Committee has started on its first draft and is continuing discussion on this matter.

After discussion, it was the Board's consensus to defer this discussion pending HPCA's proposal.

Scope: a. Inquiry by Renee Conner (re: Bed Bug Detection Service)

The Board reviewed a letter from Renee Conner dated May 12, 2011, inquiring whether a pest control license is required to offer or provide bed bug detection services using trained dogs. According to Ms. Conner's letter, she proposed to use dogs and provide "independent services to pest control companies and other commercial businesses to detect bed bug infestations".

It was moved by Ms. Nakasone, seconded by Mr. Burnett, and unanimously carried that Ms. Conner's proposed service appears to fall within the following definition of "pest control" in Hawaii Revised Statutes section 460J-1":

"Pest control" means, with respect to wood-destroying pests, or other pests which may invade households or other structures, including railroad cars, ships, docks, trucks, airplanes, or the contents thereof, the engaging in, offering to engage in, advertising for, soliciting, or performing the following for hire:

- (1) Identifying pests or infestations;
- (2) Making an inspection for the purpose of identifying or attempting to identify infestations of household or other structures by pests; "
 (Emphases added).

Accordingly, the Board determined that the services Ms. Conner intends to provide requires a pest control operator's license.

b. D.O.A. Inquiry re: usage of pesticides and other chemicals

The Executive Office referred to an email from Christina Y. Zimmerman, Department of Agriculture, regarding an inquiry that she received from a member of the public who was concerned about the kind of pesticide used by the property manager around the complex. The public member is asking if the property manager or any other type of contractor applying pesticides around a building or residence was required to notify residents of what kind of pesticide was applied or at least provide the information if requested.

Discussion followed. It was the Board's consensus that it did not appear to fall within the definition of pest control; however, to apply pesticides on premises, the property manager shall be in compliance with the Department of Agriculture if restricted use chemicals are used.

New Business:

a. Election of Officers:

Vice Chair Yates opened the floor for nominations for the office of Chairperson. It was moved by Mr. Fukuyama, and seconded by Mr. Burnett to nominate Vice Chair Yates as Chairperson. Being that there were no further nominations, it was moved by Mr. Fukuyama, seconded by Mr. Burnett and unanimously carried to close the nominations and Dr. Yates was unanimously elected as Chairperson.

Chair Elect Yates opened the floor for nominations for the office of Vice Chair. It was moved by Chair Yates, and seconded by Mr. Koide to nominate Mr. Fukuyama as Vice Chair. Being that there were no further nominations, it was moved by Chair Yates, seconded by Mr. Koide and unanimously carried to close the nominations and Mr. Fukuyama was unanimously elected as Vice Chair.
