Rule Revision - "Definitions" to Chapter 95 Review & Discussion

The members began their review and discussion of the proposed definitions for $\ensuremath{\mathsf{HAR}}$

Chapter 95.

The Committee discussed the following terms under the "definitions" section of HAR Chapter 95:

- "ACPE" new definition, amendment proposed to accurately reflect ACPE's previous name
- "Administer" new definition, amendment proposed to also include "intranasal"
- Automated data processing system" revised existing definition for clarity
- "Board" new definition, proposed deletion since already defined in HRS Chapter 461

- "BREG" new definition
- "CDC" new definition
- "Collaborative agreement" new definition, still under consideration
- "Deliver" new definition, still under consideration
- "Device" new definition, amendment proposed to include reference to HRS 328-1
- "Director" existing definition, proposed deletion since already defined in HRS Chapter 461
- "Dispense" revised existing definition for clarify, still under consideration
- "HRS" new definition
- "Immediate supervision" revised existing definition for clarity
- "Institutional facility" existing definition, proposed deletion since already defined in HRS Chapter 461
- "Medication therapy management services" new definition, still under consideration
- "Order" new definition, still under consideration
- "Partnership" new definition
- "Pharmacy intern" amended definition for "Pharmacy assistant"
- "Pharmacy technician" revised existing definition for clarity
- "Pharmacist care" new definition, still under consideration
- "Prescriber" existing definition, proposed deletion

- "Wholesale distribution" revised existing definition for clarity
- "Wholesale distributor" revised for clarity, still under consideration

The Committee determined that more revisions to the definitions section may be done as the Committee goes through the rest of the rules.

Board of Nursing APRN-Rx Controlled Substances Prescriptive Authority Notification to Pharmacists and Pharmacies

The Chair stated that it may be helpful for the Board to provide information to the pharmacists on the practice and prescribing privileges for advanced practice registered nurses ("APRN"), especially since they will begin prescribing controlled substances. He stated he has mentioned this to the EO and they have been working on an information sheet to be posted on the pharmacy web page that includes information on how pharmacists can verify an ARPN's license and/or specialty.

Proposed Emergency Preparedness Statutory Amendment

The Chair stated that he will be contacting someone from the Department of Health to see if they are favorable to amending the HRS relating to emergency preparedness and recognizing pharmacists during an emergency as one who is able to provide services without liability.
