EO Taniguchi introduced the Board's new EO, Kenyatta Nichols. He informed the Board that EO Nichols would be taking over as of January 11, 2012.

The Chair thanked EO Taniquchi for assisting the Board as their interim EO.

EO Taniguchi informed that Board that he was told that the Governor's office would be submitting Ms. Kubota's name to the Legislature for appointment to the Board.

Open Forum:

The Chair asked Ms. Kubota if she would like to address the Board.

Ms. Kubota said at the last meeting, the Board discussed PTA licensure and having HAPTA take a more active role in that process. She spoke to HAPTA's legislative team and they are planning to take the next year to put together a coalition, fundraise to pay for lobbying and also look at how the American Physical Therapy Association ("APTA") has assisted other states with obtaining PTA licensure.

The Chair suggested that HAPTA send a survey to their members to find out needed information such as how many PTAs there are in Hawaii.

Ms. Kubota informed the Board that HAPTA's new President is Art Lum. Ann Frost is now HAPTA's legislative chair. She asked if the Board has any report on the status of the continued competency issue.

The Chair noted that the first step would be to complete the questions in the Professional and Vocational Licensing Division ("PVL") Continuing Professional Education Guidelines – Checklist ("Checklist"). She said the Board would welcome any assistance HAPTA can provide. She said the Board believes that continued competency and PTA licensure are equally important issues.

EO Taniguchi suggested presenting each issue as a separate bill. This way if the Legislature has a problem with one of the issues, the other will not be affected

negatively. He also suggested completing the questions within the next three months.

Ms. Kubota asked if there was another method besides legislation to obtain licensure for a profession.

EO Taniguchi said that unless it is an emergency situation, the only way would be through legislation.

Upon a motion by the Chair, seconded by Mr. Turner it was voted on and unanimously carried to approve the creation of a continued competency investigative committee, made up of the Chair, Mr. Turner and Ms. Iopa.
