Mr. Schultz stated he is retired military and is currently the Director of the Pacific Regional Disaster Preparedness Center ("PRDPC") under the Federal Emergency Management Agency ("FEMA").

Mr. Schultz asked the Board if training providers other than the University of Hawaii Community Colleges are allowed to provide security guard training? The PRDPC, a non profit organization, is authorized through FEMA to provide security training and all other FEMA courses to civilians free of charge as long as their funding continues and feels they can provide the required 8 hours initial training and continued education as well. The Board explained that the intent of having the HCC provide the training insured that all guard employees would be trained from the same manual for the initial 8 hours and subsequent CE courses. It is a means to standardize the training.

Chair Mack informed Mr. Schultz that he can submit the PRDPC security guard training proposal with the fee structure for the Board's consideration.
