Member:

Kenneth Chang – Industry Member

The Executive Officer welcomed and introduced Mr. Chang as the interim Board member appointed by the Governor to replace Mr. Owens. Mr. Chang currently holds both private detective and guard licenses, and is the private detective licensee member. Mr. Chang is a retired Honolulu Police Department lieutenant with 25 years of police experience. He was in the Criminal Investigation Division from 1978-1985 specializing in arrests, criminal property damage, white collar and sex crimes. Mr. Chang was also the recruit training field commander. Upon retirement, he provided security officer training for in-house security companies on Oahu. He also headed the Airports Division and was Operations Manager at Wackenhut, Securitas, Pinkerton Consulting and Investigations until he established Kiamalu consulting and Investigations and Kiamalu Security Services in 2010.

Chairperson Inouye appointed Mr. Chang to the Applications and Curriculum Review committee.

Wrap up

Mr. Galas reported that Jeff Owens made recommendations to clarify workplace violence and that he will incorporate the changes and provide it to the Board at its next meeting.

Mr. Denis asked if the Board, the Governor, or the legislature could extend the July 1, 2013 effective date since the bulk of the applications cannot be reviewed on time and that there is a liability

issue for employers attempting to comply and those who are not aware that they have to comply with the law. Deputy Attorney General ("DAG") Tam responded that according to the law, the effective date of the law is set and there is no statutory authority to extend the date. Because the Legislature is not in session, the Legislature is unable to extend the deadline and the Governor probably cannot use his executive powers to extend the deadline.

The Executive Officer stated that there were problems with the FBI background check review and that there are numerous applicants with questionable background checks that the Board must review. Mr. Galas asked if more help could be added. The Executive Officer responded that the Applications Review Committee can meet to review applications subject to Board ratification and that the department felt it was more efficient to pay for overtime than to train two additional employees. DAG Tam added that the Board could meet more often.

c. Securitas Background Checks for Airport Personnel

The Board determined that it will accept the Securitas background checks for those employees working at the airport who are frequently required to submit to background checks as a condition of employment if the FBI and State report were generated within six months of the date of the application.

d. Email from April Inano requesting determination if Transportation Security Officers (TSO) are subject to the requirements of Act 208

Vice Chairperson Yabuta stated that airport screeners do not act in a guard capacity and they call the LEOs if necessary. The screening is performed by federal employees and on federal property. Mr. Chang added that under Homeland Security, they have arrest powers but the Board should request a complete job description.

It was moved by Mr. Galas, seconded by Vice Chairperson Yabuta, and unanimously carried to defer the Board's determination if TSOs are subject to the requirements of Act 208 pending verification as to whether the screening area is considered federal property, or Homeland Security is a law enforcement agency and therefore exempt from the requirements of Act 208.

e. Email reply from Public Safety Director, Ted Sakai regarding enforcement powers of the State deputies, sheriffs and investigators.

Ted Sakai's email response clarified that the state deputy sheriffs and investigators have enforcement powers at all times (24/7).

It was moved by Mr. Galas, seconded by Vice Chairperson Yabuta, and unanimously carried that the State deputy sheriffs be considered to be active duty law enforcement officers because they have a duty to respond and have enforcement powers "24/7", and therefore exempt from the requirements of Act 208 even if they are employed part-time as a guard for another private employer.

f. Criminal Convictions

The Executive Officer informed the Board that the guard employee applications that have FBI matches will require Board review.

The Board delegated the Executive Officer to approve guard employee applications with DUI and contempt of court convictions reported on the FBI report.

The Board recessed the meeting at 2:20 p.m. and will reconvene on Wednesday, June 26, 2013 at the King Kalakaua Conference Room at 9:00 a.m. The meeting was recessed to give the Board more time to review the voluminous amount of guard applications.

The Board reconvened its June 20, 2013 meeting at 9:25 a.m. on Wednesday, June 26, 2013.

Chairperson Inouye announced that he was returning to the Curriculum Review Committee Report to address the security guard training curricula submitted.

Mr. Chang noted the following deficiencies in the American Guard Services Curricula:

- The 8 major topics as outlined in the Board's approved curricula including all subtopics shall be covered. Indicate where each required element is covered.
- Required time allotments for topic discussion are not provided.
- The mandatory 8 hour training shall be universally applicable to all areas of security and should not be site specific.
- Advise "Implied Arrest" is no longer required.
- Copy of examination.

It was moved by Mr. Chang, seconded by Vice Chairperson Yabuta, and unanimously carried to rescind the prior approval pending review by the Applications and Review Committee and to defer the American Guard Services Curricula pending the submission of lesson plans, and verification that their program meets these guidelines set forth in the Board's approved curricula.

4) Guardsmark, LLC Course Curricula

Mr. Chang informed the Board that the applicant can delete the "implied arrest" portion in the curricula and noted the following deficiencies:

- i. "Citizen arrest" is incorrectly stated because all arrests must be by made by a person present; a security officer cannot make an arrest based on another person's statement.
- ii. The Professional Image and Aloha training does not appear sufficient for a 30 minute block.
- iii. No exam section was submitted. Examinations may be developed for each module or a final exam to ensure that the guards understood the curricula being taught and that they have been trained.

It was moved by Vice Chairperson Yabuta, seconded by Mr. Chang, and unanimously carried to defer the approval of the Guardsmark, LLC course curricula pending the

above to verify that the proposed training meets the Board approved curricula.

b. Ad Hoc Committee Report

Mr. Denis continued the discussion on the Guard Employee registration application process and asked if the guards need to apply by July 1 or must be registered by July 1. Ms. Sugimura stated she shared Mr. Denis' concerns because there are many associations with in-house security that want to know if their guards can work without guard cards after July 1, 2013.

Mr. Burgwinkel informed the Board that all the guard employees at G4S have received the 8 hour training but about 40% of them may not have submitted their applications. Mr. Medeiros added that about 60% of Star Protection employees have applied for their guard cards and that he is aware of several small companies that have not even started training their employees. Mr. Denis stated that proprietary groups not regulated by the Board probably have the majority of guard employees that are not in compliance.

To help address the fingerprinting issue with Fieldprint's policies and procedures, Mr. Medeiros informed the Board that Star Protection is offering fingerprinting services, seven days a week until 11:00 p.m. and that they also provide classes at night. He also added that Star Protection will accept cash or check payments for the fingerprinting services which Fieldprint does not. Mr. Medeiros added that a problem guard agencies experience is large turnovers because the majority of the employees stay less than two years.

Mr. Chang stated that proprietary companies are now calling for training services because they originally did not take the law seriously.

Executive Session: It was moved by Vice Chairperson Chief Yabuta, seconded by Mr. Chang, and unanimously carried to enter into executive session pursuant to HRS sections 92-4 and 92-5, to consult with the Board's attorney on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities and to consider sensitive matters related to public safety or security in accordance with HRS sections 92-5(a)(4) and (6) at 9:55 a.m.

EXECUTIVE SESSION

It was moved by Mr. Chang, seconded by Mr. Akiona, and unanimously carried to reconvene to the Board's regular order of business at 10:12 a.m.

After further discussion regarding the concerns about the guard employee registration applications, Deputy Attorney General ("DAG") Tam informed the guests that the Legislature is not in session, the Governor probably cannot use his emergency powers and the Board cannot issue a grace period to extend the registration deadline for the guard employees, and proposes the following June 26, 2013 "Important Announcement Regarding Guard Registration Applications Filed Before July 1, 2013 Under HRS Section 463-10.5 (Act 208 (SLH 2010))" for Board approval:

"June 26, 2013

IMPORTANT ANNOUNCEMENT REGARDING GUARD REGISTRATION APPLICATIONS FILED BEFORE JULY 1, 2013 UNDER HRS SECTION 463-10.5 (ACT 208 (SLH 2010))

At its June 26, 2013 meeting¹, the Board of Private Detectives and Guards ("**Board**") voted to issue the following guidance to address questions regarding the guard employee registration applications that have been filed with the Board pursuant to the new registration and training requirements specified in HRS section 463-10.5 (Act 208 (SLH 2010)).

1. The new requirements

Effective July 1, 2013, HRS section 463-10.5 requires all guards and employees who act in a guard capacity to apply to register with the Board and meet the following registration, instruction, and training requirements prior to acting as a guard:

- a. Be not be less than eighteen years of age;
- b. Possess a high school education or its equivalent;
- c. Not be presently suffering from any psychiatric or psychological disorder which is directly related and detrimental to a person's performance in the profession;

- d. Not have been convicted in any jurisdiction of a crime which reflects unfavorably on the fitness of the individual to act as a guard, unless the conviction has been annulled or expunged by court order; provided that the individual shall submit to a national criminal history record check as authorized by federal law, including but not limited to the Private Security Officer Employment Authorization Act of 2004, and specified in the rules of the Board;
- e. Successfully complete eight (8) hours of classroom instruction; and
- f. Undergo four (4) hours of on-the-job training².

2. Applications filed with the Board before July 1, 2013

Although the new requirements are applicable as of July 1, 2013, the Board began accepting guard registration applications in January 2013. Before an individual may be registered, the Board reviews each application to ensure that the above requirements have been met and the Board's staff does a criminal history records check on each individual applicant. If the application, information, and records demonstrate that all of the above requirements have been met (including but not limited to a determination that the criminal convictions, if any, do not reflect unfavorably on the fitness of the individual to act as a guard), the Board approves the application and issues the applicant a guard registration card.

Because HRS section 463-10.5 is broad and affects many individuals that were not previously subject to HRS chapter 463, a significant number of applications have been and are continuing to be filed with the Board prior to July 1, 2013. The Board is diligently trying to review and process the thousands of applications before this date. If the Board finished reviewing an application and determined that the applicant satisfied the above requirements prior to July 1, 2013, that applicant was or will be issued a guard registration card that will be effective as of July 1, 2013.

However, despite its best efforts, the Board may not be able to finish reviewing the backlog of applications filed prior to July 1, 2013. Although the new law does not provide a grace period, the Board believes that the following is a reasonable solution to temporarily address the backlog:

- a. If an individual submitted an application before July 1, 2013 and attests³ that the applicant meets all of the above requirements, that applicant shall be allowed to continue working as a guard after July 1, 2013 subject to the Board's review of the application.
 1. If the Board subsequently reviews the application and confirms that the applicant meets the above requirements, the Board shall issue that applicant a guard registration card that shall be retroactive to July 1, 2013.

² The four hours of on-the-job training ("OJT") are not required to register as a guard under HRS section 463-10.5. However, the OJT hours are provided by an applicant's employer and are required prior to acting as a guard.

³ The guard registration application form requires an applicant to attest to the accuracy and truthfulness of the information provided in the application. To expedite the processing of applications, the Board will initially rely on any such attestation, and subsequently verify the applicant's information and records.

The Board notes that any misrepresentation on the application may constitute grounds to refuse to register the applicant as a guard, and is a misdemeanor under HRS sections 710-1017, 436B-19, and 463-4.

2. If, however, the Board subsequently determines that an applicant has not met all of the above requirements, the applicant shall not be issued a guard registration card and the applicant may be guilty of engaging in unregistered guard activity.
- b. If an individual submitted an application before July 1, 2013 but the applicant indicates that one or more of the above requirements may have not been met (e.g., the application indicates that the applicant has been convicted of a crime in any jurisdiction that has not been annulled or expunged), the applicant shall not be allowed to continue working as a guard until the Board determines that the applicant meets the above requirements.
 1. If the Board subsequently reviews the application and confirms that the applicant meets the above requirements, the Board shall issue that applicant a guard registration card that shall be retroactive to July 1, 2013.
 2. If, however, the Board subsequently determines that an applicant has not met all of the above requirements, the applicant shall not be issued a guard registration card and the applicant may be guilty of engaging in unregistered guard activity.
3. Applications filed with the Board on or after July 1, 2013

If an individual submits an application on or after July 1, 2013, that individual cannot act or continue to act as a guard until that individual is issued a guard registration card by the Board. The guard registration shall be effective from the date the guard registration card is issued (i.e., there shall be no retroactive effective date of the registration).”

Mr. Denis asked if the employer will be notified if an employee receives a deficiency notice. The Executive Officer responded that the employer will not be notified. Deficiency notices are sent to the applicants. He commented that the background checks conducted by the state does not relieve the employer from conducting their own background checks. DAG Tam stated that by July 1, 2013, if an employee answers “yes” to questions 3, 4, or 5 (i.e., that the employee has been convicted of a crime that has not been annulled or expunged), the individual cannot be allowed to continue to work. The Board cannot sanction the individual to continue to work if the Board has been notified that the individual has answered “yes” to questions 3, 4, or 5 and if the employee has applied after July 1, 2013, he/she cannot work until they receive a guard card. Because the burden has now been shifted to the Board and the State to determine whether an individual qualifies for guard registration or not, and must evaluate the individual’s criminal background, the Board cannot

allow that individual to work as a guard without reviewing the individual's criminal background. Ignoring the individual's criminal background could expose the Board and State to liability.

It was moved by Vice Chairperson Yabuta, seconded by Mr. Akiona, and unanimously carried to adopt the June 26, 2013 Important Announcement Regarding Guard Registration Applications Filed Before July 1, 2013 Under HRS Section 463-10.5 (Act 208 (SLH 2010)).

Vice Chairperson Yabuta suggested that companies be proactive by informing their employees who answer "yes" to questions 3, 4, or 5, to submit statements explaining the underlying facts and circumstances of the conviction(s), court documents and letters from counselors and the community attesting to their rehabilitation before the Board has to defer their application to request these documents.

Mr. Denis added that companies should perform their own checks and do not have to hire an individual just because they possess a guard card. The decision to employ someone is still up to the employer, not the Board.

f. Criminal Convictions

The Executive Officer asked the DAG Tam to review the list the Board approved as some of the items approved were excluded on the condensed list.

Scope:

a. Letter from John L. Shouman, Fire Protection Consultants forwarded by Dawn Kubota, PVL Examination Branch regarding whether a private investigator's license is required to provide instructional classes on fire investigation.

It was the consensus of the Board that a private investigator's license is not required to provide instructional classes on fire investigation.

Lisa Kubota from Hawaii News Now arrived with a camera man and asked if she could get a statement from the Board on film regarding Act 208 (SLH 2010). The Board complied with her request and restated the above positions and interpretations.

The Board recessed at 11:00 a.m.

The Board reconvened at 11:15 a.m.

Chairperson Inouye announced he was taking the agenda out of order to address the guard employee applications and ratification list.

Executive Session: It was moved by Vice Chairperson Chief Yabuta, seconded by Mr. Chang, and unanimously carried to enter into executive session pursuant to HRS section 92-4 and 92-5, to consider and evaluate personal information relating to the applicant applying for licensure at 11:17 a.m.
