<u>Correspondence</u> :	a.	February 11, 2012 letter from Bruce Kam, PsyD regarding postdoctoral hours
		Members reviewed a letter from Bruce Kam, PsyD dated February 11, 2012, regarding postdoctoral hours.
		Discussion followed. In regards to Dr. Kam's first question as to whether his "supervisors (non-licensed psychologists) can coerce [him] to sign off [on] clinical hours that [he] did not supervise", the Board suggested referring Dr. Kam to two separate sections of its administrative rules.
		First, Hawaii Administrative Rules ("HAR") § 16-98-8(b)(2), states that a person who holds a doctoral degree from an accredited institution shall have completed the following supervised experience:
		 Has completed at least one thousand nine hundred hours of postdoctoral experience in the field of psychology. The experience shall be under the supervision of: (A) A licensed psychologist; or (B) A person who holds a doctoral degree in psychology or educational psychology from an accredited institution, granted prior to 1970, and is listed in the National Register of Health Sonvice Provider in Psychology or
		Service Providers in Psychology; or(C) A person who is a diplomate, by examination, of the ABPP.
		Second, HAR § 16-98-34(b), states:
		 The psychologist shall not misrepresent the professional qualifications, affiliations, and purposes, and those of the institutions of and organizations with which the psychologists is associated: (4) A psychologist shall not associate with or permit the psychologist's name to be used in connection with any service or products in such a way as to misrepresent them, the degree of psychologist's responsibility for them, or the nature of the psychologist's affiliation.
		With regards to Dr. Kam's second question as to whether the Board can assist him with resolving his employment situation at OCCC, members indicated that matters dealing with employment are not

within the Board's purview, therefore, it would not be able to provide or offer assistance to Dr. Kam.

Lastly, the Board advised that this response is an informal interpretation in accordance with HAR § 16-201-90. It is not an official opinion or decision, and therefore is not to be viewed as binding on the Board or the Department of Commerce and Consumer Affairs.

b. <u>March 8, 2012 email from Sherine Ramzy, PhD regarding postdoctoral</u> <u>supervision by a licensed psychiatrist</u>

Members reviewed an email from Sherine Ramzy, Ph.D., dated March 8, 2012, regarding postdoctoral supervision by a licensed psychiatrist.

Discussion followed. First, the Board advised that it is not able to make a formal decision regarding whether Dr. Ramzy would be eligible for licensure until a formal application is submitted with the Board's office.

Second, with regards to the Board's requirements regarding supervision, pursuant to Hawaii Administrative Rules ("HAR") § 16-98-8(2), postdoctoral experience in the field of psychology shall be under the supervision of:

- (A) A licensed psychologist; or
- (B) A person who holds a doctoral degree from an accredited institution, granted prior to 1970, and is listed in the National Register of Health Service Providers in Psychology; or
- (C) A person who is a diplomate, by examination, of the ABPP.

Third, with regards to Dr. Ramzy's doctoral degree, Hawaii Revised Statutes ("HRS") § 465-1 defines an institution of higher education as a university, professional school, or other institution of higher learning that:

- In the United States, is regionally accredited by bodies approved by the Council on Postsecondary Accreditation and the United States Department of Education;
- (2) In Canada, holds a membership in the Association of Universities and Colleges of Canada; or
- (3) In other countries, is accredited by the respective official organization having such authority.

Fourth, the Board also advised that at the time Dr. Ramzy submits her formal application, she must also submit a completed Training Report.

Lastly, the Board advised that this response is an informal

interpretation in accordance with HAR, Title 16, Chapter 201, § 16-201-90. It is not an official opinion or decision, and therefore is not to be viewed as binding on the Board or the Department of Commerce and Consumer Affairs.
