Call to Order: There being a quorum present, the meeting was called to order by Chairperson Hackbarth at 1:30 p.m.

Introduction of Keali'i S. Lopez, Director, DCCA: Keali'i S. Lopez, Director, Department of Commerce and Consumer Affairs ("DCCA"), thanked members for volunteering their time, expertise, and commitment to the Board of Psychology and the consumers of the State.
