# Executive Officer's Report:

a. Record of Candidates Examined: For the Examination for Professional Practice in Psychology (EPPP)

Executive Officer Quiogue reported that there were a total of two (2) candidates who took and passed the EPPP exam as of December 15, 2012.

# New Business: a. <u>Hawaii Psychological Association: New Legislation</u>

Alex Santiago, Executive Director, Hawaii Psychological Association ("HPA"), appeared before the Board to discuss new legislation.

Mr. Santiago indicated that Senator Gilbert Kahele would be reintroducing legislation relating to prescriptive authority for psychologists during the 2013 Legislative Session.

The proposed legislation would have similar language to Senate Bill No. 1004, S.D. 2, H.D. 2, C.D. 1, which was vetoed during the 2007 Legislative Session.

Mr. Santiago indicated that while the HPA is supportive of Senator Kahele's efforts, it did not request, nor is it planning to introduce separate legislation regarding prescriptive authority for psychologists.

Mr. Santiago informed members that other prospective legislation would be for the certification of applied behavioral specialists ("ABA"). These specialists currently specialize in the treatment of individuals with autism.

Executive Officer Quiogue asked Mr. Santiago if he knows which State agency would be responsible for regulating ABAs.

Mr. Santiago indicated that he was not sure who would regulate this area.

Executive Officer Quiogue indicated that if the proposed legislation regarding ABAs affects the Board's statutes in anyway, then it would submit testimony. However, if it did not, then it may not be appropriate for the Board to comment on such legislation.

Executive Officer Quiogue referred back to the proposed legislation for prescriptive authority, and asked Mr. Santiago to briefly summarize the language in the 2007 legislation as most members and staff were not with the Board.

Mr. Santiago answered that the proposed measure would provide trained psychologists, licensed in Hawaii, with limited prescriptive authority for the

specific purpose of providing care in Federally Qualified Health Centers ("FQHC").

Mrs. Hackbarth recalled that the Board had several concerns regarding the use of psychotropic medications being prescribed to the very young and elderly.

Executive Officer Quiogue requested that Mr. Santiago provide any proposed legislation to the Board for its review.

Chairperson Nowak thanked Mr. Santiago for attending the Board's meeting to discuss this issue.

Mr. Santiago left the meeting room at 1:45 p.m.
