### **Legislative Bills and Report**

CAI – Hawaii Chapter Legislative Request – The banker’s association did not provide a response in writing to the Commission regarding CAI’s request.

Commissioner Abrams suggested that the Commission support the bill to repeal the sunset provision since it would benefit the consumers and the condominium associations.

Upon a motion by Commissioner Abrams, seconded by Commissioner Kuriyama, it was voted on and unanimously carried to approve supporting legislative bills to repeal the sunset provision of Act 39 (SLH 2000).

Legislative Timetable – A copy of the Legislative Timetable was distributed to the Commissioners for their information and reference.

Legislative Report No. 1 – A copy of Legislative Report No. 1 was distributed to the Commissioners for their information. The Commissioners and staff person assigned to the bills were asked to decide on whether or not the Commission would be submitting testimony on the bills affecting the Commission.

It was reported that House Bill No. 363 was held in Committee. Commissioner Loudermilk and the SEO testified at the hearing. HAR also submitted similar testimony to defer the bill. There was no one present at the hearing that was in support of the bill.

The EO reported that the SEO and Senior Specialist Yee were at the Legislature this morning attending a hearing.

#### Licensing – Ratification:

Upon a motion by Commissioner Kuriyama, seconded by Commissioner Ball, it was voted on and unanimously carried to ratify the attached list.

#### Licensing – Applications:

The EO informed the Commissioners that the information provided to the the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue which is personal in nature, they have the right to request that their application be considered in executive session.

#### **Linda L. Blomquist**

Linda L. Blomquist was present to answer any questions that the Commission may have regarding her application for a real estate salesperson’s license. Ms. Blomquist was asked if she wished to have her application considered in executive session. She declined the offer.

Ms. Blomquist explained that she had a corporation and was approached by someone who wanted to buy it. Her research indicated that the buyer was an upstanding individual. She did not do enough research and did not find out until later that this was not the case. She had some obligations that she would keep and the buyer was assuming responsibility from a certain point. She took six

months and tried to fulfill every obligation that she could for the corporation. She later had to file for bankruptcy. It took her until December 2006 on a personal level to try to do everything that they could to fulfill her obligation. She sold her house and everything else. The business was founded in 1999 and was sold in 2005. Her problems began in 2005. There were two allegations of deception and fraud as a result of dishonored checks. The FBI went to the location and from what she heard; the buyer was not doing business as they had done. He had other interests and used the business as a front and got caught. She was current on all of her payments until she sold the business.

Upon a motion by Commissioner Kuriyama, seconded by Commissioner Abrams, it was voted on and unanimously carried to take this matter under advisement.

### **Sheldon Blair K. Glassco**

Sheldon Blair K. Glassco was present to answer any questions the Commission may have regarding his application for a real estate salesperson's license. Mr. Glassco was asked if he wished to have his application considered in executive session. He declined the offer.

Mr. Glassco informed the Commissioners that when the incident happened, he had been trying to find himself. He did not have any guidance. Since then, he got married, had a child, and has turned his life around. He has not been in that situation for six years. He is currently employed at Ciao Mein in the Hyatt Regency Hotel.

Mr. Glassco was informed that frequently a part of his duties may involve driving customers and that the Commissioners were concerned about his ability to do so. Mr. Glassco stated that he understood that. Mr. Glassco said that the second DUI incidence was a big wake up call for him. As a part of his community service, he helped out by cleaning at the Waikiki Community Center and helping in their preschool.

Mr. Glassco informed the Commissioners that he does not drink any more and has not done so for three years. It tapered off after the last incident. He had been a social drinker when he was with his friends. Since his marriage, he does not drink, neither does his wife. He goes home right after work.

Upon a motion by Commissioner Kuriyama, seconded by Commissioner Loudermilk, it was voted on and unanimously carried to take this matter under advisement.

### Executive Session:
