Commissioner Kuriyama was excused from the meeting. Prior notification of his non-attendance was received.

Condominium Specialist's Report: Specialist Yee announced that the seminar procurement has been posted to the HePS site with a deadline date of May 15, 2013. Those interested must be registered through HePS as a vendor and submit an electronic proposal through HePS. The Commission may award more than one contract either by island or statewide. The scope, term, and compensation have been included with the solicitation.

It was also reported that the June committee meetings will be held in Kauai at the Lihue State Office Building on June 12, 2013.

Condominium Governance and Management:

AOUO Registrations

Specialist Stone reported that as of April 30, 2013, 1,668 AOUOs have successfully registered for the 2011-2013 biennium.

For the 2013-2015 AOUO re-registration, 300 registrations have been received online during the month of April and 98 received so far in May.

Mediation and Arbitration - Extension of Mediation Agreements - Mediation Center of the Pacific, Inc., Mediation Services of Maui, Inc., West Hawaii Mediation Center, Ku'ikahi Mediation Center, Kauai Economic Opportunity, Inc.

Mediator services, pursuant to HAR §3-120-4, have been determined to be exempt from the procurement procedures of HRS Chapter 103D by the procurement policy board effective July 17, 2008. Mediator services fall under exemption number 12. The committee took note of the essential role mediation providers play in the condominium community, the number of cases mediated this fiscal year, and the services performed by the mediators.

Upon a motion by Commission Harvey, seconded by Commissioner Senter, it was voted on and unanimously carried to extend for one fiscal year all current Mediation Agreements, subject to the same terms and conditions of the current agreements.
